

Statement of the Ministry of Reconciliation after the call of NGOs

FOLLOWING THE CALLS FROM NGOS, THE OFFICE OF THE STATE MINISTER FOR RECONCILIATION AND CIVIC EQUALITY SAYS IT HAS BEEN HELPING REGIONS BEFORE AND DURING THE PANDEMIC.

According to the Ministry of Reconciliation, at the beginning of the pandemic information about coping with infection and preventive measures were translated into Abkhazian and Ossetian languages. According to them, in order to share the experience, online consultations for local doctors are held on a regular basis and Georgian specialists are always ready to give relevant advice.

Since the region opened to tourists on August 1st, there has been a sharp outbreak of infection in Abkhazia. On August 16th alone, 26 cases of COVID-19 infection were detected in Abkhazia, three times higher than the previous day and the highest rate.

The Georgian authorities have been urged to use both their own resources and the assistance of international organizations to assist Gali residents, and to involve them in the provision of basic necessities and medicines.

Part of the population living in the Gali district, who used to receive IDP benefits in the territory controlled by Georgia, is no longer able to receive assistance in the conditions of the pandemic due to the restrictions imposed by the de facto government.

According to the Georgian government, with the support of the Georgian authorities, a mission of the World Health Organization was carried out in the region of Abkhazia to assess the situation on the ground and develop recommendations.

To deal with the pandemic, the Georgian government and international organizations regularly provide medical equipment, medicines and hygiene items to the Abkhaz region. People infected with coronavirus are being treated in the controlled territory of Georgia. In particular, since the outbreak of the pandemic in the occupied Abkhazia, four patients, including two from the medical field, have been transferred to the central government-controlled area for treatment. One of them has already recovered while three are undergoing treatment. A field hospital has been opened near the Enguri Bridge, where local doctors measure fever for each patient from the occupied territories and transfer them to various medical facilities according to complaints. In order to treat infected patients, the Gray Hospital was equipped and started work to build easier access to free medical care for the people living in the occupied territories. According to the agency, up to 1,000 people have left the occupied territories controlled by the central government since March 22nd, of which 316 patients in need of emergency medical

care were taken directly to hospitals with various diagnoses, and the person received appropriate medical care after quarantine.

The Office of the State Minister notes that in the direction of Akhalgori, the Tskhinvali region remains completely closed and artificially isolated. According to them, the government has immediately expressed its readiness to help the local population, both publicly and through international partners and the hotline, but so far this is not possible.

The only crossing in Abkhazia, which according to an EUMM study was carried out by up to 2,000 people a day, has been closed in Georgia since February 27th this year, after the first case of Coronavirus was detected in Georgia. In Tskhinvali, the Bibilov regime closed the administrative border much earlier. Residents in the conflict zone speak of the unbearable humanitarian situation after the pandemic. The Georgian-speaking population of Gali and Akhalgori, in particular, who were mainly dependent on the Georgian market and Georgian pensions and social assistance, were particularly affected. NGOs called on the Georgian government to step up humanitarian and medical assistance in the wake of the COVID-19 bomb blast in occupied Abkhazia on August 18th. According to the signatory organizations, it is important for the Georgian government and society to show drastic steps of solidarity.

The leaders of Lelo For Georgia speak up about legal system malfunctions

LELO LEADERS SPOKE AT A BRIEFING TODAY ABOUT THE UNINVESTIGATED CASE OF TORNIKE MEREBASHVILI AND THE SIMILARITIES BETWEEN THE AFOREMENTIONED CASE AND THE CASE OF GIORGI SHAKARASHVILI.

T he leaders of the political party recalled Tornike Merebashvili, who was killed on July 6th, 2018, and once again informed the public that the investigative bodies are taking the case in the wrong direction. According to Lelo, Merebashvili's real killer is free, and the person whose guilt has not been confirmed has been sentenced.

According to Ana Natsvlishvili, one of the leaders of Lelo, the same prosecutor is involved in the cases of Merebashvili and Shakarashvili.

"Today we are talking about a very serious case related to the murder of an 18-year-old boy, which is still uninvestigated. His parents have been asking for one thing for two years now - to find out who killed their son and, unfortunately, instead of the investigators answering this question, the investigation has been busy falsifying the case and claiming a false version. This case is also distinguished by the fact that a person who is known to be guilty and is currently in prison is not proven to have committed this crime and, consequently, on the one hand, due to a wrong investigation by

the state, the parents cannot get justice and on the other hand, an innocent person is sitting behind the bars. Investigative agencies did not conduct any investigative actions aimed at establishing the truth," stated Natsvlishvili.

"Despite the numerous pieces of evidence in Tornike Merebashvili's case, the investigation is going in the wrong direction, the case is being deliberately falsified," added Kakha Kozhoridze, one of the leaders of Lelo. The leaders have two Samkharauli conclusions issued in 2018-2019. Both conclusions contradict each other as they are independent. The expert's report refutes Samkharauli's conclusion. The family and their lawyer have filed a number of complaints, but the case is still uninvestigated. According to Kozhoridze, it is noteworthy that the prosecutor in this case, Nana Gugutishvili, is also the prosecutor in the case of Giorgi Shakarashvili.

18-year-old Tornike Merebashvili was found dead on July 6th, 2018, on the Gori-Mejvriskhevi road. According to the MIA, an investigation started under the Article 115 of the Criminal Code of Georgia – bringing a person to suicide. In the course of investigation, the qualification of the charge changed into Article 117 Part 1 and Article 276 Part V of the CCG – intentional grave injury of another's body and violation of security or exploitation rules of the vehicle which caused the death of a person.

Over 30,000 to Join the Freedom Chain for Belarus

A ugust 19th, 2020. On August 23rd, 1989, around 2 million Lithuanians, Latvians, and Estonians held each other's hands to form a 600 km long peaceful human chain called the Baltic Way - an act of bravery that foreshadowed the collapse of the Soviet Union two years later. Now, Lithuanian activists are organizing a similar initiative to express the country's solidarity with neighboring Belarus in the fight against the authoritarian regime.

very well—which is why the country must help to achieve it. "It is wonderful to see such support and unity among the people. Volunteer organizations, Vilnius City Municipality, the police, the Lithuanian Riflemen's Union, the Lithuanian National Radio and Television joined us on the first day. When there is such a strong support, everything is possible. And Lithuanian cities are inviting people for local solidarity chains and organizing buses to the main event. Lithuanians in London will also hold hands in a symbolic Freedom Chain in Hyde Park, and Latvians, Estonians and Ukrainians have too expressed their interest in joining the campaign.

Laisvės TV will broadcast the event and invite political experts for discussion. An ad hoc app Walk15, available in Lithuanian, English and Belarusian, will mark the routes of the Freedom Chain in all countries.


The historical uprising in Belarus started in early August, when Alexander Lukashenko, who has ruled for 26 years, rigged the presidential election and claimed a landslide victory against the opposition leader Svetlana Tikhanovskaya. The massive protests brought violence to the streets as the riot police used rubber bullets, flash grenades and teargas to maintain control, and many people ended up being beaten or kidnapped in broad daylight. The situation has captured international attention, with the majority of political leaders denouncing the authoritarian regime and asking for a fair election.

European Council confirms EU intention to impose sanction against those responsible for post-election violence in Belarus

n 19 August, the EU heads of state or government discussed the situation in Belarus, following the presidential elections on 9 August.

President of the European Council Charles Michel said that the EU had been following the developments in Belarus very closely and with increasing concern.

"The 9 August elections were neither free nor fair, therefore we do not recognise the results," he stressed.

"The members of the European Council condemn the disproportionate and unacceptable violence displayed by the state authorities against peaceful protesters," added Mr Michel, reiterating that "violence must be avoided and all those unlawfully detained must be immediately and unconditionally released".

Charles Michel added that the EU will soon impose sanctions against a substantial number of individuals responsible for violence, repression and the falsification of election results.

"Progress made in the past years in the relationship between the EU and Belarus is at risk," he said. "Any further deterioration of the situation will impact on our relationship and have negative consequences".

The European Council called on the Belarusian authorities to find a way out of the crisis through de-escalation and inclusive national dialogue.

In conclusion to the meeting, the European Council President said that the EU would continue to follow the situation closely and stand ready to contribute to ending the crisis peacefully.





Coronavirus: European Commission continues expanding future vaccines portfolio with new talks

T he European Commission has concluded exploratory talks with CureVac to purchase a potential vaccine against CO-VID-19 on 20 August.

This is following the positive steps with Sanofi-GSK on 31 July and Johnson & Johnson on 13 August and the signature of an Advance Purchase Agreement with AstraZeneca on 14 August.

The envisaged contract with CureVac would provide for the possibility for all EU Member States to purchase the vaccine, as well as to donate to lower and middle income countries or re-direct to European countries.

It is anticipated that the Commission will have a contractual framework in place for the initial purchase of 225 million doses on behalf of all EU Member States, to be supplied once a vaccine has proven to be safe and effective against COVID-19. The Commission pursues intensive discussions with other vaccine manufacturers.

On 6 July, the European Investment Bank and Cure-Vac signed a €75 million loan agreement for the development and large-scale production of vaccines, including CureVac's vaccine candidate against COVID-19.
