To the UN, the EU, world's scientists, the press and mass media Conference material relating to the issues on the unified system of global governance and the state structure improvement

The urgency of the problem and its solutions

Against the background of technical progress, mankind faces the urgent problem of creating a unified system of world governance, since the current governance system cannot provide a solution to the problems facing mankind in order to avoid the confrontation between states and regions, which negatively affects the solution of socio-economic issues facing humanity. Governing a country and region should be carried out taking into account complex issues, without the involvement of any persons, requiring improvement and should be the subject of discussion:

- 1. How do you conceive the unification of the public defender, trade unions, veterans, political parties, religious representatives, youth, press and media in consolidating authority of society, making it a supreme body to which the president and prime ministers are accountable?
- 2. How do you conceive the election of the president taking into account the regional governors, mayors, ministers, deputies and members of parliament, and the election of the world president by the presidents of countries and their deputies?
- 3. How do you conceive the elections of a regional governor by society, elections of a mayor by governors of districts and their deputies, elections of ministers by heads of departments, and deputy ministers, and the election of prime minister by ministers and deputies?
- 4. How do you conceive the activities of political parties in the structures of the district, city, and ministry to solve significant problems facing the country, taking into account competition?
- 5. How do you conceive the current electoral system from the point of view of the government, the state, the region and global governance system, taking into account legal socio-economic issues? How justified is the confrontation of the elected one to the people, how justified is that the problem with the country is solved on the streets and that no one is responsible for constant protests?
- 6. How do you conceive to hold elections every 6 years, under the same legislation, at the same time, taking into account the world; should the involvement of society in protests and elections be considered to be the final solution to problems?

- 7. How do you conceive the existence of a legislative body in the consolidating body, the press and media; should a civil servant take preparatory courses, should a civil servant's creative program be assessed in advance?
- 8. According to the new system, a candidate gives voters ballots divided into two parts, with the appropriate number. Within 30 days, a voter must vote for a candidate and return the ballot paper, one part of which is transferred to CEC. During this period, a candidate will openly publish on the course of voting, and this will bring to a close ongoing confrontation.
- 9. How do you conceive the transformation of the Ministry of Economy and Ministry of Finance into one department (Ministry) together with planning services, as well as the decision-making by the Ministry of Justice and courts independently on any crimes which can be appealed in the 2nd and 3rd instances? If independent investigative services are created for each industry, the prosecutor's office will become the coordinating body.
- 10.All state structures should have centers for analysis and forecasting, coordinating services, the formation of a unified state governing system by staffing more qualified specialists.
- 11. Will the creation of a unified system of world governance condition the improvement of a unified system of defense, science, culture, art, trade, financial and monetary system, domestic and foreign policies, a unified legal framework, labor resources, migration, rational use of natural resources and other issues?

In addition, I ask to demand from the administration of the presidents of all teaproducing countries to assist me in reimbursing me the royalties for the production of tea using new technology - without rolling by natural drying since 1998, taking into account international legislation. As for the application of the above innovations, they can be used on the basis of a contract, by transferring copyright and entrepreneur's standards.

The legislation prohibits the use of the invention without the consent of the author.

The topic - problems, issues of meeting the vital needs of mankind in the conditions of technological progress and issues of creating a unified system of world government and state structure improvement

1. Medicinal and food products obtaining, processing, keeping and using by means of new technology.

In the conditions of technical progress, meeting the growing needs of mankind for ecologically clean food and medicine is very important for the preservation-production, processing, keeping, sale, use of raw materials compositions without heat treatment by means of new technology, in order to avoid losses.

65% of elements existing in a plant extract are appropriate to the existing content of a human body that gives a way to cure 46 complex diseases. Bringing microelements in it is a way to cure inflectional and fungus diseases in an intensively short time. It also can be kept at room temperature for years, taking in account new coronavirus.

In 1997 by using new technology, natural tea was produce without rolling and thermal recycling, but with natural drying. In such a way it is possible to preserve 80%-85% of the substantial elements of tea. Due to the significance, it was set up in the whole world and the demand is increasing annually. The plant extract has a great deal either for meal or in medical treatment which has been used since 1993 in the group of plant extract. There is no any alternative way in reserving natural elements in the terms of ecology, economic,-social and security. It is also very important to use treatment extracts in veterinary for animal treatment and to use eating extracts for feeding them in winter conditions. In natural drinking juice in the terms of treatment and nutrition, it is very significant to vindicate its content elements.

Acceptance of plants, livestock products and medicines without the use of energy resources is very important in solving the problems of globalization in the conditions of technical progress, which considers the correct alignment of fields as a key factor in the transition to industrial rails, as a result, a new conceptual vision was formed in the field, which leads to the synthesis of the field of physics, chemistry, biology, in order to comprehensively solve the existing problems by combination of the fields, which in today's conditions becomes impossible by means of existing medicines.

1. Reduction of material and labour costs taking into account scientific research. 2. Rational use of natural resources and employing the workers. 3. Safe treatment of complex diseases with ecologically clean products, plant and livestock products, which have a positive impact on human psychology in the intensive period (taking into account production-processing, storage, sale, use). 4. Under the technical progress, it is more important to obtain

ecologically clean products without thermal processing (without the use of energy resources). Today it is very important to eradicate global confrontation between society and the state, for this purpose the problem will be solved by creating a system of unified world management, where the consolidation of the society, the regional governance of the state, the protection of human rights, increasing intellectual creativity are crucial.

A new complex approach to the problem will significantly reduce the conflicts facing humanity, which are permanent. If international organizations get involved to solve the problems after the wars, why cannot it be solved with creating unified world management system? As we know war has not spilled over benefits for any formation. The world must come out of the existing problems and get strong decisions. Due to the current necessity of creating a unified management system, it is impermissible to pass on the power of parliament to the government, since they are competent to solve 80% of existing issues worldwide. Its place will be taken by centers and branches of public consolidation, regional governance, human rights protection, and regional intellectual creativity.

Problems have been positively reviewed in scientific institutions, ministries, in relevant committees of parliament, structures within political parties, government, UN and EU etc.

Editorial board of the publishing house "Academy", the group of initiative supporters hopes that these issues will be the subject of discussion of the public and the science, recommendations, conclusions about which should be sent to the author. 1. Implementation of new technologies for efficient food and medicinal products processing and producing.

The actuality of the issue: the existence of human being increases demand for first and foremost the use of nutritional and effective medicines for maintaining life. For this purpose it is necessary to improve the production level by implementing new technologies to rationally use the natural resources of the region, to receive ecologically clean and competitive products with less material and expenses. To maintain the maximum capacity of its composition – production, processing, storage and use of existing raw materials, to achieve the full correlation between the product and the human body that is a very difficult process. The solution is to look here. With a daily intake of 2000 kcal of food, while maintaining 30% of the composition, in terms of calculating minimum USD 2, conventionally 7.5-8 billion per year taking into account the population, the economic effect exceeds hundreds of billions, taking into account other costs. The introduction of these technologies will provide the

synthesis of physics, chemistry, biology, the transfer of the branch to new industrial rails, and a comprehensive solution to the problems facing medicine.

Problems solving: To maintain all components of existing raw materials for the efficient use of food and medicines, it is critical to obtain paste - extract from the plants roots, stems, leaves and fruit by new technologies, which can be stored at room temperature within a year; it has been used since 1993.

1. Tumor; 2. Herpes; 3. Hepatitis; 4. Goitre; 5. Psoriasis; 6. Cardiovascular system; 7. Digestive system; 8. Eczema of skin diseases, gangrene, neurodermatism; 9. The dryness of the mouth; 10. Feeling cold in the joints; 11. Atherosclerosis; 12. Undesirability; 13. Dysfunction; 14. Air failure; 15. Increase strength; 16. Adenoma; 17. Some diseases of tuberculosis; 18. Infectious and fungal disease; 19. Tympanophonia; 20. Numbness in the extremities; 21. To restore blood vessels; 22. Diabetes; 23. Worms; 24. Pressure; 25. Due to the disappearance of the black dots to improve vision; 26. For painkillers; 27. Swelling; 28. Eructation; 29. Metabolism; 30. For the treatment of genital disease; 31. Cicatrix; 32. To clean the poison from the digestive system. 33. Restores muscles, rejuvenation. 34. Deteriorates the inflammatory process of funds. 35. Helps restore bone tissue, promote calcium balance in bone tissue. 36. Treatment of inflammatory process in grips. 37. Toothbrush recovery. 38. Treatment of Stress. 39. Removal of Dialysis; 40. Parkinsonism; 41. Nodes; 42. Coronavirus etc.

It should be noted that 60-65% of the composition of these extracts coincides with the composition of human organism that positively affect the treatment of the above mentioned complex diseases. Keeping of fish, poultry, pork, beef, sheep, other meat in the extract obtained using new technology for a long time at room temperature is very important. It is critical to obtain extracts from any fruit, citrus, vegetables, berries and cucurbits for food, treatment and in the production of alcoholic drinks, and it are kept at room temperature within 12 months. This technology has been used since 1993. Consumption of natural juices will contribute to the development of culinary production during the winter, especially in terms of childhood nutrition with respect to patients.

It is great for the use of cattle breeding in the field of treatment and food as well as for the use of other farming areas. The use of such technology helps the use of sea algae for feeding and treatment. As the novelties in the treatise are the issues of global importance, it is difficult to present the most economical efficiency in full with the consideration of different factors which exceed hundreds of billions. This is also about issues related to perfection of management.

There was a case when a patient received four - five times above the norm, but it had not any adverse effect. During the first two courses of the cancer treatment the patient has severe

pain, reaction and during psoriasis treatment the number of exfoliation increases by 20% in the initial process.

According to the psychological norms, 7,3 billion of the world population will be satisfied with food grains $7x10^{15}$ kg of calories every year. For this purpose, we need 569x109kg calories, milk 1x1015kg calories, eggs $2x10^{12}$ kg calories, potatoes 708x109 kg calories, $131x10^9$ kg calories, vegetable oil $51x10^9$ kg calories, bread products $883x10^9$ kg calories, and parsley, vegetables $1x10^{12}$ kg calories, sugar $131x10^9$ kg calories. For this purpose, the level of production is needed to increase 35%, which is very difficult process. The crucial importance here is the introduction of new technologies in the field of agriculture and industry.

- 2. Occasionally, as a result of the treatment of trauma, iron cannot be removed from the patient's body for years, which negatively affects his health; this issue concerns the use of intensive medications in the treatment of trauma, where the entire organism and individual organs are fixed without iron for treatment. Using any of these extracts as an ointment, can be used in any place where the patient can be taken. Economic effect is calculated by economy as a result of existing means reducing, amounting to 35-40 %.
- 3. New alcohol making technologies are important for alcohol drinks, where all types of raw materials are used as energy sources. The construction is mobile, minimizing losses during alcohol processing, which will contribute to the development of farms. The economic effect of 1 liter of alcohol is 35%. It is a positive assessment of the use of food extracts in beer production, as well as various dry drinks that do not have any alternative in the perspective.
- 4. New technology for making yogurt (matsoni) and cheese are adopted by one sorted system in room temperature for 11 months. To make yogurt (matsoni) it is not necessary to boil milk and it is kept for 12 days without refrigerator. Aroma products are obtained that are positive for digestive and nervous system and others. Sprinkling of aromatic cheese and sulgunade is stored in the room for 4 months, which can be used for bread making instead of yeast (matsoni/natural yogurt has been made in Georgia since classical times). The effectiveness of refrigerator equipment, industrial space, energy resources is 35% of one-liter matsoni/yogurt processing, which amounts to tens of billions of dollars worldwide per year, taking into account other factors.
- 5.Beef, lamb, poultry, pork, all kinds of fish are stored in the plant extracts obtained using new technology, it retains its aromatic taste during 6 months without smoking, and 9 months without salting.
- 6.It is very important to get healing water with new technology, which differs from other waters in terms of physicochemical parameters. It is stored for up to 1 year, it has a positive effect on the digestive nervous system, etc. Great is its role in drug recycling.

- 7. It is potentially productive to take aquatic algae for food and treatment when mankind suffers from deficiencies in the above-mentioned issues.
- 8. The new technology received as a result of tea natural drying considers rolling, fermentation and artificial withdrawal, resulting in the aromatic tincture of blackish colour that is not characteristic for any type of tea. Extractive substance is 48%, and tannin is 9%. It is important to use medical extracts for the treatment of psoriasis, eczema, cardiovascular and nervous system, etc. It is very important to get tea and medication without thermal processing, stored in room conditions for 11 months. These technologies have been used since 1997, and as a result of which there has been noted use of green tee more than 1,5 in the world.
- 9. The new technology of bread making where the cooking zone is not covered by gas, all kind of energy resources used for fuel are mostly clay. We get hot water. Bread is made on seven floors with a complex mechanism. It is very important to take care of the meat and cheese smoking-hamming in the canning process. The structure is moving. It is important to note that the introduction of the new technology of medicinal bread that is very important is 6 species of granular and leguminous plants with high aroma and long lasting maintenance (2-3 days) without yeast. The economic impact of this bakery, in contrast, exceeds tens of billions of dollars a year, considering the reduction of energy resources worldwide, etc.
- 10. Specialized, semi-trailers and wagon containers carrying cattle and wild beads with all types of vehicles, whose trial samples are recommended to be introduced in the Traceka project where cattle are transported by three to four floors. Approximately 26% of cattle are transported by rail, and 44% by car transport. It is very important to transport livestock by means of vehicles for winter and summer pastures, as well as to keep weight in meat products. The semi-trailer variant of 60% increases by placing 98 cm floors between the wheel and the third floating floors. Parameters: 11x4, 5x2,5 meters, nutrition, metabolism are provided on all three floors. Economic efficiency in both types of transport, taking into account the weight maintaining of fuel, electricity, spare parts loading and unloading operations.
- 11. In the production of alcoholic and nonalcoholic beverages, the food and medicinal extracts have been long stored in a barrel container, the lower and lateral parts of which are laid or arranged with red clay ceramic from the inside, while the upper part is used for disinfection of micro elements. The structure is moving. Container keeps fit and economic efficiency is determined by indicators of storage of raw turnover, etc., which is 500-700 liters, 25% of the respective raw materials value.
- 12. Planning New Library: from the repository to the reader the book is delivered by complex mechanization automation, in terms of infrastructure, it is crucial to improve management, which is positively reflected on the quality of intellectual creativity. With a minimum dismissal of 45 personnel, the economic effect is 7.2 million dollars per year for one

object, in comparison with the construction of a single item and other material costs, resulting in better management of sanitary hygiene norms in the repository.

Creation of a unified system of the world management and state structure improvement

1. Improvements to the world unified management system

Urgency of the problem: means of solution are characteristic of all social formations of the controversy between society and states, which is necessary by creating a unified system for elimination. Today, when the production, sale and use of products are considered in one context in the world, which is considered to be a fundamental condition for the existence of the state, the question arises why a unified management system cannot be created.

The solution to the problem is to create a unified system of the world facing the humanity, which differs from the existing system of government, where the consolidation of society and governance of the state, protection of human rights, raising the level of intellectual creativity will be discussed in one context. For this purpose it is necessary:

1. Establishment of a centralized management system that maintains the balance of power between the center and the periphery according to the principles of democracy. 2. Consolidation of the society. 3. Considering the unified economic, social, social structure and religion of the state between the regions. 4. Proper coordination of fields in the region, specialization, raising the level of concentration, efficient use of technological potential. 5. The rights of the state, society and officials are strictly separated. By creating a strong legal framework so no problems are possible in the society as the problems of the state are part of the problems of the society and vice versa. All problems must be solved by mutual agreement, by a unified system of government, in order to minimize individual decision-making, the regions and the world must be governed by this system, in order to avoid conflicts between states.

Global confrontations between states are more complex process than regional conflicts involving conflict, needed to be resolved. Any confrontation between states still remains the subject of joint discussion by different states. Numerous examples from the past point to this. Naturally, the vision of the large states of this issue will be offbeat, at this point, in total, confrontation of the larger states causes socio-economic losses and so on.

There is no simple commandment of the global problem, especially in the conditions of technical progress, it is necessary to involve the world community in different ways. It is inadmissible for a population of 8 billion not to have a unified system of government and to run it with passion. The management of the world is more or less carried out by the UN, EU and CIS countries, which indicate that there is a necessity to manage the world in a centralized

way to minimize the conflicts between countries, which negatively affect the development of humanity.

In condition of technological process, neglect of the religion, consolidation of society, intellect and other factors when managing the mankind is inadmissible; in resolving this issue, the great importance is given to the creation of a unified world system of governance to minimize conflicts between states, which have been permanent for years.

The implementation of these issues will eradicate global confrontation between states, which is a substitute factor. Confrontation can no longer be considered as a means of peace. The issue should be determined only by means of proper management. It is unacceptable to make a decision alone.

For this purpose it is necessary to create a unified constitution of the world, to elect president, chairman of parliament, prime —minister by representatives of the respective states. The center and the component states must create a controlling body in the society that will control the entire management system of the country, with the Public Defender and Human Rights Structure. The controlling body will be created by units represented on the basis of peripheral organs. The above mentioned structure should be able to present candidates recommended by them two or three days prior to the elections, so as to limit its influence to the electoral company; conducting such elections will minimize the controversy between the subjects. Realization of the above-mentioned issues will facilitate:

- 1. Formation of the structure of the Uniform Defense and Law Enforcement Agencies.
- 2. Centralized management will facilitate the global development of the field of public sector rational use of natural resources workers between the continents and so on.
- 3. Creating a unified scientific potential facilitates rational use of the natural resources of the planet.
- 4. The point is to apply the environmental and territories embezzlement that are permanent for years.
- 5. The creation of a single currency system will contribute to the development of trade culture and other spheres among individual continents.
- 6. The global confrontation between states will be minimized, which is very dangerous with allowances made for socio-material issues.
- 7. It is important to establish a common belief in the face of mankind, to strengthen peace in the world, which is considered to be a problem for all formats.
- 8. Since there is no uniform system of management in the states there is no obligation to meet the obligations in each of the states which negatively affect the global problems in the world.

It is unfulfilled about the issues that are to be addressed to humanity, which is permanent every year.

- 9. Establishment of a Unified World Management System, deputies within the Parliament, representation of all states will better protect the interests of religion, tradition, territory of own country, and other views.
- 10. Minimization of the influence of large states on the smallest states; management system existing do not have an obligatory requirement of performance mechanisms for anybody, only in the nature of the recommendation.
- 11. By enacting a uniform constitution, self-consciousness and responsibility of individual governing politicians will be increased to protect their interests other's interests.
- 12. Minimization of the influence of individuals on the small states management for own interests realization.

Participation of lawyers, economists, military specialists and scientists is necessary in order to develop a view of common opinion to solve a more complex issue. Taking into account other issued, I hope that scientists, public officials and society will be able to show understanding for the current problem solving, which has been for the longest time that all the planet's inhabitants are able to dispose of their own future of faith, for which he/him has appeared in the world – to perform his duties. Even if every state takes the initiative to postpone the violence-war for 4 days, what a material and spiritual wealth will we maintain in different areas, which is achievable for everyone for years!! It is inadmissible to pursue personal goals by force against the interests of others because both parties have appeared in this country in the same way.

2. Unifying Financial and Economic offices together

Simplification of the existing management system, the relationship between the society and the state, taking into account economic, social, legal issues, etc. will enable us to establish a unified world management system. It should also be noted that the correct coordination, specialization and concentration of the fields is very important. This is mostly concerns the quality of the economic relationship as one of the forms of connection between states. In this case, it is necessary to establish the Ministry of Economy and Finance as one agency. In the conditions of technical progress it is very important to develop the natural resources, to use the man power rationally, to increase the level of specialization and concentration. In order to meet the growing needs of the population with minimal material labor costs on food and industrial products, etc., proper coordination of the sectors of the national economy will facilitate the management of the country through a single system of government, from the

center to the periphery and vice versa. The work of all ministries should be based on the development of natural resources, the development of the regions of the country, the satisfaction of the population of industrial cities with food and industrial products, etc.

All state structures should be monitored by the executive, legislature, etc, the relevant center for analysis-forecasting, which should produce, recycle, and sell the natural resources. So the Centers for Analysis and Management of industrial ministries should be managed by the Unified Management System of the country, by the Academy of Sciences. Complex management should be based on the results of 10-15 years. The Economic and Financial Service should be established in the Ministry, as a single structure.

- 1. Analysis and prognosis scientific center.
- 2. Planning department in industrial ministries.
- 3. Department of education, science and innovation.
- 4. Department controlling using natural and work force resources.
- 5. Privatization and business department.
- 6. Income and control department.
- 7. Financial and budget department.
- 8. Department for relationship with foreign countries, trade and tourism.
- 9. Department for administrational issues.
- 10. Department for legal issues.
- 11. Audit department.
- 12. Department for industrial work.
- 13. Department that communicates with administrative organs, public and press.
- 14. Emergency response department.

Existing services in ministries should merge with relevant departments. Head of economical department should be economist and his deputy - financier, and vice versa in financial department. Minister / economist should be chosen inside ministry. Analyses and prognosis center will be responsible for quality work of ministries. This center should be staffed with qualified professionals, who should monitor every other department.

Society chooses an executive structure of the government, which should govern public industries, which perform 80 % of work. Ratio should be the same in structures between states. The structures within the parliament should substitute the structures of the government, i.e. establishing a consolidating and executive body of the society in one form will be enough

to govern any state. The consolidating body of the society should include political parties that will participate in the reconstruction of the country in conditions of competition, with the appropriate remuneration for their intellectual creativity. He/she will be presented to executive organ and will be appointed as a representative and not a deputy. This means that political parties will be used as a mean to form executive structure (using consolidating organ).

In such situation, president's role is to balance the power between central and peripheral organs to create unite governing system, to prevent the division of governing system into autonomies. Ministries should choose their ministers and prime minister should be chosen by ministers or consolidating organ. Conceptually, it becomes impossible to establish a unified system of government without the consolidation of sectors and societies, which is mainly related to the establishment of a unified system of government in the world, and this creates a growing demand for a unified legal framework that addresses religious and racial issues in the interests of the community (region). As there is a tendency to form a unified management system of the world, a unified system of management must be implemented to minimize the confrontation between society and states, and so on. Due to the complexity of these issues, they should be implemented in stages.

3. Issues of investigative and judicial improvement

Under all formalities, human rights should be protected, in order to protect human rights in accordance with law it is necessary to establish one system of existing investigative and judicial structure. In this case, any offense will be more efficient in one structure rather than separately, resulting in a substantial reduction of material and livelihood cots. All offenses subject to the separation of civil, criminal, and administrative cases require the acquisition processing, and review of various evidence, which is a very difficult process. To this end, it is necessary to unite the judicial and judicial system. The investigative structure should be able to conduct itself in accordance with in investigation and give legal assessment as a through ruling. If it is necessary to appeal the decision by the Party, he will appeal to the Appeal and Supreme Court, and review will be considered as the first instance court. Establishment of the Uniform Structure of the Investigation Court facilitates the acquisition of evidence on an issue, in order to minimize the interference of different persons, the impact will be limited to one body.

It is necessary to divide-group civil cases according to complexity. Simple cases can be judged by administrative procedures, and relatively complex issues should be referred to the court for which a legislative framework should be created with the requirement to minimize material and time costs. Responsibility for all hearings should be assumed by the first instance, so the party should not have to choose who is responsible for responding to the matter, obtaining evidence, appointing an expert examination, etc. In such a case, the entire burden falls on the investigative and judicial structure of the first instance, thus relieving the

second and third instances, respectively, and this shall significantly improve the quality of competition. It will facilitate the complex introduction of a unified management system that has no alternative. The unification of all existing investigative divisions into a unified system will facilitate the formation of a single block of scientific research, forensic science, and media, which should be subject to the prosecutor's office and the parliament. According to the decree, the heads of regional, district and central services must be elected by the public for a term of 6 years.

4. Issues of State management improvement

For any formation it is necessary to consolidate the society and not to confront it. When the society elects the governing bodies it should retain a function of state control in some form to avoid unfinished controversies which negatively affect the ongoing processes of the society. Controversy largely indicates the weakness of management systems.

It is necessary to consolidate the society where political parties, war veterans, youth, non-governmental organizations, religious representatives and others will join. Their representation should be determined by 50% of the elective bodies.

A unified representation of the executive, the legislative and the public will have a beneficial effect on the perfection of governance. The division of the management system into autonomies has brought the country to this state. The functions of the controlling bodies should be transferred to the public, as the state will not be without society, society will not be without economy, government, religion, territory, and so on. In order to establish a unified system of governance in the regional context - autonomy, it should be studied as separate elements, taking into account the region priorities. Public consultation will help to increase competition between political parties. They must be able to protect the rights of their citizen in any country. It would be good if we discuss with them the press and media, together with the trade unions, to create a unified public system that will be focused on protecting the public interest.

The starting point of consolidation will be for the individual to take a worthy place in the elected bodies in accordance with his or her values. Creating a unified "background" of the society will help to purposefully select the cadres in advance according to their creativity. Today's electoral system fails to respond to state management requirements, resulting in a confrontation between political parties and the public, which negatively affect the country's rebuilding. The motivation is that a parliamentarian and official cannot meet today's demands. Consolidation of forces, state management must be carried out from periphery to the center and not vice versa. It is necessary to establish a state management academy for the training of graduates. We must look for a solution in intellectual creativity. The division of governance systems into autonomies had a negative impact on the reconstruction of the country. The academy will train civil servants in accordance with the main priorities of the country. They

must be nominated by the district board (one or two candidates) until a public consolidation body is established. According to the presentation of the district population, who will become a "cadet" after passing the entrance exam, who will be elected after graduation in the same district or in unforeseen circumstances elsewhere, etc. The Academy should ensure the coordination of the electoral system with regard to the organizational issue, which will be accountable to the consolidating body of the society. Forming the issue in such a way will help to continuously train the staff that will be focused on the reconstruction of the country.

- According to all districts, for the formation of the parliament, there will be enough 200-250 deputes (or civil servants) for the five -million inhabitants, resulting in the parliamentary and governmental "foundation", If a parliamentary candidate receives more than 50 % of votes, he/she should be elected as a majority by the principle of majority;
- If a parliamentary candidate receives less than 50 % of the votes, the elections must be either in the majority of votes or by the majority vote;
- The candidate should be elected on the position of Chairman of the Parliament in case of more than 50% of the voters;
- Candidates who fail to get 50 % of the vote for the post of Chairman of Parliament should be elected by the Parliament by a majority of votes;
- If more than 50% of voters vote for the election of a candidate for the position of President, the candidate must be elected President by a majority of votes;
- Candidates who fail to get more than 50 % of the vote for the presidency must be elected by the Parliament by a majority of votes;
- If the voter votes more than 50% of the vote for the presidential position, the candidate shall be elected president by a majority of votes.
- Candidates who fail to get 50 % of votes for the presidency must be elected by Parliament by a majority of vote.

In order to improve the electoral quality of the President, the Speaker of the Parliament, the Prime Minister in a state of emergency, 50 % must be elected from the 250-member parliament, or government foundation, to get the "elite", i.e. 63 persons are again elected out of 125 men, who in turn elect three candidates - the President, the Speaker of Parliament and the Prime Minister. In case of their disagreement, a person shall hold a position according to the lottery.

It is very important to introduce a new ballot paper form, where the name of the parliamentarian and the presidential candidate is nominated. Name, surname, place of residence and position of the mentioned voter shall be indicated on both sides of a ballot paper

(identical number). When electing a candidate, a voter shall leave the left part of a ballot paper. In case of dispute, he/she will prove his participation in election by means of his/her number.

"Difference approach" is required by the prime minister election. According to its specificity and complexity, the issue of governance is largely dependent on it. The Prime minister should be elected by the Ministers as well as their first Deputies. In the election, the Presidential Administration is given 15 votes, the Speaker of the Parliament, and the chairpersons of the committees – according to conformality. Parliament and the Presidential Administration are exceptionally allowed to nominate a candidate for the Prime Minister.

It is inadmissible to set a limit on participation of political parties, public organizations, individuals in elections. Elections in and of itself are election and re-election. It is not allowed to set a limit on it. In the conditions of holding elections, the truth must win. Everything should be directed to the combination of as many opinions as possible; by means of this system we can elect the district governor, mayor, minister, etc.

The term of the election should be determined for 5-6 years, as a great deal of time is spent on establishing the structure of governance.

In order to improve the organizational issues, the presidential, parliamentary self-government elections need to be held in one day and be declared an important day. A deputy who does not fulfil his/her promises within 9 months must be recalled by the voters by a majority of vote according to submission of his/her report.

Changing the existing electoral system will remove many barriers, reduce aimless confrontations and, most importantly, create a belief in society that the rule of law will bring social and material good to the people, increase belief, which should be done invariably by the rule of law.

It is unallowable to consider the hunger strike to be a basis point by its form-content, related to the spiritual -social issues of the human being. In this case the preference should be given to a referendum consisting of 51% of the population, and the executive structure (administration) should be responsible for its fulfilment; when holding a strike after 3 days of non-compliance, the party is obliged to compensate the damage to the other party, taking into account the non-compliance to avoid unintended consequences.

Every four years GEL 108 million is spent in conditions of 4 million voters in Georgia, i.e. 45.2 million dollars -in conditions of 7.3 billion people worldwide taking into account 5.2. billion voters, for the presidential, parliamentary and self-government elections, and this amount does not include the costs incurred as a result of the disputes, it also should be taken into account the economic indicators obtained as a result of the improvement of the election term and quality, and in total the economy will exceed one billion with a minimum

calculation. If 5% of the amount spent around the world on elections and war was spent on intellectual creativity, diseases, hunger would be reduced by at least 50%, and society would not be divided into classes, etc.

Penalties for material and moral injuries shall be imposed in connection with the holding of a strike, liability shall be imposed on the party, the wrongful action of which resulted in the holding of a strike and 70% of the total amount shall be accrued for the benefit of the winning party, and 30% - into the budget. This legislation should be applied to criminal acts caused by wrongdoing during elections, which resulted in electoral fraud, re-election etc. As there are two views on the reduction of the rights of the Parliament and the granting of powers to the executive body should be considered as a transitional period, until the issue is resolved.

5. Program requirements for candidates to take position in elective bodies

To take the position candidate should present program accepted by society 4 months prior to the elections, according to reviews by political parties, scientists, State officers, religion representatives, veterans etc.

Candidate for Presidency, Prime Minister, Minister, City Mayor, Deputy and an alternate candidate is obliged to present the main staff of those persons with whom he/she has to work with. Society should be informed about fulfillment of the obligations in every 8-9 months. If the obligations are not fulfilled, electorate has right to recall him/her. Candidate should pay attention to:

- 1. Main fields for improving the State, considering the perspective.
- 2. The main priorities of the country's economic development, Proper arrangement of the fields, perfection of specialization-concentration; development of the natural resources in accordance with the requirements of scientific-technical progress and consideration of workers' employment.
- 3. According to the main factors determining the domestic and foreign policy of the country.
- 4. Strengthen the defense capabilities of the country and secure the legal base and active engagement of the community.
- 5. Cooperation of scientific potential of the country, education and science, intellectual creativity of youth in politics, business, religion etc.
- 6. Solving Social Problems.
- 7. Considering the region's exploitation of natural resources and solving ecological problems.

8. The candidate should give the above and other issues a complete reliability in the political, economic and social context, at the scientific level, in view of the prospect of solving existing problems.

I hope the creative approach will facilitate the proper management of the state system in order to eradicate confrontations that are permanent.

Conclusion: In the conditions of technical progress, meeting the growing needs of mankind for ecologically clean food and medicine is very important for the preservation-production, processing, keeping, sale, use of raw materials compositions without heat treatment by means of new technology, in order to avoid losses by 45%.

65% of elements existing in a plant extract are appropriate to the existing content of a human body that gives a way to cure complex diseases. Bringing microelements in it is a way to cure inflectional and fungus diseases in an intensively short time. It also can be kept at room temperature for years, taking in account new coronavirus

In 1997 by using new technology, natural tea was produce without rolling and thermal recycling, but with natural drying. In such a way it is possible to preserve 80%-85% of the substantial elements of tea. Due to the significance it was set up in the whole world and the demand is increasing annually. The plant extract has a great deal either for meal or in medical treatment which has been used since 1993 in the group of plant extract. There is no any alternative way in reserving natural elements in the terms of ecology, economic, social and security. It is also very important to use treatment extracts in veterinary for animal treatment and to use eating extracts for feeding them in winter conditions. In natural drinking juice, in the terms of treatment and nutrition, it is very significant to vindicate its content elements.

Acceptance of plants, livestock products and medicines without the use of energy resources is very important in solving the problems of globalization in the conditions of technical progress, which considers the correct alignment of fields as a key factor in the transition to industrial rails, as a result, a new conceptual vision was formed in the field, which leads to the synthesis of the field of physics, chemistry, biology, in order to comprehensively solve the existing problems by combination of the fields, which in today's conditions becomes impossible by means of existing medicines.

1. Reduction of material and labour costs taking into account scientific research. 2. Rational use of natural resources and employing the workers. 3. Safe treatment of complex diseases with ecologically clean products, plant and livestock products, which have a positive impact on human psychology in the intensive period (taking into account production-processing, storage, sale, use). 4. Under the technical progress, it is more important to obtain ecologically clean products without thermal processing (without the use of energy resources).

Today it is very important to eradicate global confrontation between society and the state, for this purpose the problem will be solved by creating a system of world unified management, where the consolidation of the society, the regional governance of the state, the protection of human rights, increasing intellectual creativity are crucial.

A new complex approach to the problem will significantly reduce the conflicts facing humanity, which are permanent. If international organizations get involved to solve the problems after the wars, why cannot it be solved before the war with creating unified world management system? As we know war has not spilled over benefits for any formation. The world must come out of the existing problems and get strong decisions. Due to the current necessity of creating a unified management system, it is impermissible to pass on the power of parliament to the government, since they are competent to solve 80% of existing issues worldwide. Its place will be taken by centers and branches of public consolidation, regional governance, human rights protection, and regional intellectual creativity.

30 inventions, 1 discovery have been examined by scientific research institutes, universities, the Academy of Sciences, Ministries, the relevant parliamentary committees, which resulted in the letter of recommendation of Georgia's government N13 824 as of 03.05.17, by which it recommended to introduce it in production taking into account foreign specialists, monographs and treatises (some issues are not subject to publication at this stage). Involving young people in regional, scientific and intellectual clubs is crucial for acquisition of independent skills and for solving these and other issues.

A world significance prize every ten years shall be established for the authors made great contributions in many fields and in solving the problems of mankind.

In the conditions of technical progress, it is very important to correctly coordinate the sectors to create a unified management system that will facilitate the development of the sectors in order to solve complex human problems. The prize shall amount to USD 10 000 000 in accordance with the relevant provision.
