Ned Price Says 'People's Power' Initiated Draft Law Threatens Georgia's Euro-Atlantic Integration

A group of deputies who left the 'Georgian Dream' initiated a bill in the parliament "on the transparency of foreign influence" according to which, the sources of income of politicians, NGOs and media should be transparent to the public.

Ned Price, the spokesperson of the United States State Department responded and said that they are deeply concerned about the bill submitted to the Parliament of Georgia.

As Price noted at the briefing, this bill may affect freedom of speech and democracy in Georgia. According to him, Washington has already expressed its concern on the mentioned issue to the Georgian side.

The State Department sees the similarity of the Georgian bill with the law on foreign agents of Russia and Hungary. Price stated that such a law will create a potential threat to Georgia's Euro-Atlantic integration. According to his statement, it is false that this bill of "People's Power" is based on American laws.

"We are seriously concerned. We know about the draft law in the Georgian parliament. We are deeply concerned about the



consequences [the draft law] might bring for freedom of speech and democracy in Georgia. We have already reported our indignation to the authorities of the Georgian side. The proposed law

will force the independent citizens of Georgia, those citizens who yearn for a better future, to remain silent.

We believe that such a law can create a potential threat to

Georgia's Euro-Atlantic integration. As for the comparison with our laws, this comparison is false, including FARA's statements that the Georgian bill is based on FARA, these statements are false. In fact, this bill is based on similar Russian and Hungarian bills, not on any other American bill," said Ned Price.

Irakli Kobakhidze Thanks Hungarian MEP For Not Supporting Adopted Resolution on Saakashvili by European Parliament

Trakli Kobakhidze, chairman of the Georgian Dream, evaluated the resolution adopted by the European Parliament on February 15, calling on the government to transfer Mikheil Saakashvili abroad for treatment as 'absurd' and adding that it has no value.

According to Kobakhidze, it seems that the Hungarian MEPs are not, in his opinion, subject to common coordination against Georgia, because they did not support the resolution about Saakashvili. He called Hungary's position healthy':

"In this case, Hungary had a healthy position. Which, of course, is very welcome and we would like to thank each and every MEP.

Second, it seems that the Hungarian MEPs are not subject to the common coordination that is against our country, against the key interests of our state," said Irakli Kobakhidze.

Irakli Kobakhidze evaluated the resolution as an attack on the national interests of Georgia by MEPs.

"Absurd records cannot have any value, and I will say once again that such a degree of absurdity would make the Supreme Council of the Soviet Union envious. It is simply incredible how absurd the resolutions are that the European Parliament adopts, this is the third time, and this third time is even more absurd than its previous two options.

Therefore, the absurd resolution cannot have any value for us. Especially since neither the first nor the second resolution was shared with either the European Commission or the European Council," said Kobakhidze.
