Irakli Kobakhidze Calls for Removal of 'Deoligarchization' Term by the European Commission to Prompt Law Cancellation

rakli Kobakhidze, the chairman of Georgian Dream stated that the Venice Commission and the European Commission are in conflict with each regarding "deoligarchization law" because the Venice Commission favors a systematic approach, while the European Commission's recommendation implies a personal approach.

"There is a contradiction between the recommendations of the Venice Commission and the European Commission. If they reach an agreement, we will follow the guidance of the European Commission. However, currently, the Venice Commission advises one thing while the European Commission advises another.

The Venice Commission expresses its disapproval of the personalized approach and emphasizes the need for reforms in various areas, which are already being implemented.

On the other hand, the European Commission advocates for a personalized approach and emphasizes the concept of deoligarchization. The term itself implies a focus on individuals, as an oligarch refers to a

To additional questions about how the instructions of the Venice Commission and the European Commission contradict each other, when the European Commission says that the problem of deoligarchization should be solved, and the Venice Commission offers a way to solve this problem, Kobakhidze said that an oligarch is a person and deoligarchization means a personal approach:

'Oligarch is a person. Deoligarchization means the implementation of a specific person's de... something. Then they said, carry out reforms. The Venice Commission has written well what a systemic approach means. Then the European Commission should share the approach of the Venice Commission, remove the word deoligarchization, and say that reforms are needed. They have internal resistance, we want clar-

The Venice Commission has assessed the revised bill on de-oligarchization and expressed doubts regarding the effectiveness of the changes made to align it with the standards of the Council of Europe on human rights, democracy, and the rule of law. In their conclusion, the Commission stated that the amended draft law should not be approved by the parliament and emphasized the need to implement a "systemic approach" rather than a "personal approach."

The Venice Commission recommends that the draft law not be adopted and that the Georgian authorities develop corrective, additional laws and measures to combat oligarchic influence. These include:

The Venice Commission emphasizes the need for a judicial system reform aimed at achieving independence and impartiality, including the Supreme Council of Justice.

"The Venice Commission emphasizes that the danger of concentrating significant influence over economic, political, and public life in the hands of a private individual may exist in any country. Most countries have developed and implemented interrelated legislative, administrative, economic, and other measures to prevent this concentration from having a destructive effect on democracy, the rule

This 'personal approach' aims to identify individuals as 'oligarchs' based on certain criteria such as wealth, ownership of mass media, etc.,

and imposes various restrictions. Although most of the restrictions have been removed in the revised version, the potential political misuse and application of provisions in this bill still pose a serious threat to the rule of law and political pluralism. We ac-

knowledge that there is no universal solution in the fight against oligarchic influence, and in exceptional, critical cases, such as during a government overthrow, radical decisions of a personal nature may be justified on a temporary and emergency

basis," the document states.

The Venice Commission believes that this "personal approach" should be seen as a supplement to a "systemic approach," not as an alternative.

"These measures must be developed in full compliance with

political pluralism and the rule of law, particularly with strong guarantees of the decision-making body's independence and due legal procedures. Currently, the draft law cannot be considered a democratic and effective response. Such de-oligarchization legislation can become a dangerous tool in the hands of political opponents of the government, leading to persecution," the conclusion reads.


