

### **European Union Ambassador Urges Systemic** Approach to De-Oligarchization in Georgia; Advocates for Professional and Independent Judicial System

he Ambassador of the European . Union to Georgia, H.E. Pawel Herczynski, stated that the Georgian side has opted for a certain approach concerning de-oligarchization. According to him, the latest recommendation of the Venice Commission clearly indicates that the approach chosen by Georgia is not considered the right one.

According to him, it is important to create an environment in which the excessive influence of oligarchs on the political system will be impossible.

"Deoligarchization is a complex issue. This is a question of the excessive influence of rich businessmen on political life. This challenge is not unique to Georgia; it also exists in other countries of Central and Eastern Europe. The Georgian side chose a certain approach. We are really grateful that the international standard setters consulted, and in the latest recommendation of the Venice Commission, which is the internationally recognized standard setter when it comes to legal issues, it is very clear that the approach chosen by Georgia is not correct. The Commission points out that this approach actually contains many risks, and the Venice Commission offers a different approach, a systemic approach.

The European Union sincerely hopes that the Georgian political elite will quickly reconsider their attitude and come up with a vision of how to solve the issue of the excessive influence of oligarchs in Georgia with a systemic approach. What does this mean? This means that we are not talking about individuals or names, but we are talking about creating an environment in which the excessive influence of



oligarchs will be impossible or very difficult," the ambassador noted.

Additionally, Herczynski expressed the desire to initiate a discussion about the judicial system in Georgia and seek the optimal solution to establish a highly professional and independent judiciary.

deliberations on substantive matters." Papuashvili said.

However, Papuashvili expressed disappointment that the opposition did not remain as engaged throughout the event. He observed a pattern wherein the opposition uses its candidate status as a tool to exert pressure on the government, resorting to blackmail and creating chaos. The Chairman lamented that when faced with a professional and calm discussion that cannot be exploited as a weapon, the opposition chose not to actively participate.

#### **Maritime Agency Confirms Arrival of Cruise Ship from** Russia in Batumi

The Maritime Transport Agency has announced that on July 27, the cruise ship ASTORIA GRANDE, sailing

#### Ukraine War, TI **Georgia Reports**

After the start of the war in Ukraine, Russian citizens have founded 21,326 companies in Georgia, which is three times more than the total number founded in the previous 27 years, according to a report by Transparency International - Georgia.

Specifically, the data reveals that from January 1995 to February 2022, a total of 7,788 companies were established by Russian citizens in Georgia. However, in the period from March

## EU support for improving food safety standards in Georgia

With EU support under the ENPARD programme in Georgia, the UN's Food and Agriculture Organisation (FAO) has launched the first support opportunity for Georgian Food Business Operators (FBOs), which have benefitted from previous phases of ENPARD. The support package will include technical assistance and a

The first phase of the EUfunded support cycle will ensure that the benefiting FBO representatives are trained on food safety. After this training, FAO will assess the equipment needs of each beneficiary to reach food safety standards. Based on the assessments, EU-funded matching grants of up to US\$50,000 will be offered for purchasing the identified equipment.

Under the EU-funded ENPARD IV, FAO will gradually launch various support packages consisting of technical assistance and matching grants to address some of Georgian agriculture's most pressing food safety challenges.
