The United States has imposed sanctions on over 150 individuals worldwide in an effort to disrupt Russian President Vladimir Putin's access to technology and financial networks that support the ongoing conflict in Ukraine. Among those targeted by these sanctions is Otar Partskhaladze.

In a US State Department document, Otar Partskhaladze is referred to as a Georgian-Russian oligarch. He held the position of Prosecutor General of Georgia for a brief period, from November 7 to December 30 in 2013.

According to a US State Department document, Otar Partskhaladze is being sanctioned in response to Russia's malign influence on Georgia. He has been included in the list of sanctioned individuals due to his involvement in the consulting sector of the economy and his ties to the management of the Russian Federation. Additionally, he holds a 50 percent ownership stake in the consulting companies MOSCOW BUSINESS BROKERAGE LLC and INTER-NATIONAL BUSINESS COR-PORATION LLC, alongside Alexander Onishchenko, who serves as an officer in the Federal Security Service of Russia.

According to the document, the Federal Security Service officer, Onishchenko, is alleged to have assisted Partskhaladze, described as an 'associate,' in obtaining a Russian passport and possibly Russian citizenship. As a result, Partskhaladze has fully embraced a Russian

The Department is also designating a Georgian-Russian oligarch and a Russian Intelligence Services officer to further address the Russian Federation's malign influence abroad.

- . OTAR ANZOROVICH PARTSKHALADZE (PARTSKHALADZE) is being designated pursuant to section 1(a)(i) for operating or having operated in the management consulting sector of the Russian Federation economy. PARTSKHALADZE is a Georgian-Russian oligarch.
- ALEKSANDR VLADIMIROVICH ONISHCHENKO (ONISHCHENKO) is being designated pursuant to section 1(a)(iii)(A) for being or having been a leader, official, senior executive officer, or member of the board of directors of the Government of the Russian Federation. ONISHCHENKO is an officer of the Russian Federal Security Service (FSB).

FSB Officer ONISHCHENKO likely assisted his associate PARTSKHALADZE in obtaining a Russian passport and possibly Russian citizenship. PARTSKHALADZE has fully taken on a Russian identity and routinely travels to Russia. ONISHCHENKO and the FSB have leveraged PARTSKHALADZE to influence Georgian society and politics for the benefit of Russia. PARTSKHALADZE has reportedly personally profited from his FSB connection.

Pursuant to section 1(a)(i), the following two entities are being designated for operating or having operated in the management consulting sector of the Russian Federation economy. They are both Russia-based management consulting companies owned 50 percent by PARTSKHALADZE:

- LLC MOSCOW BUSINESS BROKERAGE
- LLC INTERNATIONAL BUSINESS CORPORATION

Based on the document, Onishchenko and the Federal Security Service are using Partskhaladze to exert a favorable influence of Russia on Georgian society and politics. The document also states that, according reports,

Partskhaladze has received personal benefits from Onishchenko and the FSB.

Opposition leaders Levan Khabeishvili and Elene Khoshtaria addressed the sanctioning of Otar Partskhaladze.

Levan Khabeishvili, chairman of the 'United National Movement,' commented that the extensive sanctions list indicates a readiness to hold all of Putin's allies accountable. He believes that the sanctions may soon extend to the founder of the Georgian Dream, Bidzina Ivanishvili.

At a briefing on September 14, Elene Khoshtaria, leader of the 'Droa' party, viewed the sanctions imposed on Otar Partskhaladze as an exposure of the ruling party, stating, "This is the complete exposure of the Georgian Dream. It serves as a significant warning to all those who undermine the country's national interests, support Russia, and are under the rule of Bidzina Ivanishvili."

Georgia's Ministry of Defense Initiates

The Ministry of Defense of Georgia has initiated the process of declassifying agreements related to the air travel of former President Mikheil Saakashvili, following accusations against Prime Minister Irakli Gharibashvili for using government aircraft for personal purposes.

The Defense Ministry will declassify the agreements related to the former president's travel between 2010 and 2012.

"Due to public interest and media coverage, the Ministry of Defense of Georgia has initiated the declassification process for agreements related to the air travel of former President Mikheil Saakashvili.

The declassification process is being conducted by the appropriate commission within the agency, in compliance with the relevant legislation. This confidentiality pertains to agreements made between the Ministry of Defense and Georgian Airways LLC in 2010, 2011, and 2012. It's worth noting that, as per the 2012 Ministerial order, two contracts between the Ministry of Defense of Georgia and Georgian Airways LLC have already been de-

"Focusing on the daily routine of young people, I tried to delve deeper into their thoughts and feelings. In their emotions, I sometimes heard an echo of the negative collective memory passed on them by older generations," said the film director, Zviad Mchedlishvili. According to him, the young protagonists of the film have never visited Abkhazia and have not had familv ties there but respect the Abkhaz culture, traditions and language. "The filming revealed to me that for the film protagonists, Abkhazia is not just a breakaway region, but a part of their own identity," Zviad Mchedlishvili added.
