Prime Minister Irakli Kobakhidze Supports Potential Bans on Opposition Parties

On August 20, the political council of the ruling party Georgian Dream issued a statement urging the public to participate in the upcoming October 26 elections. The party emphasized the need to secure a constitutional majority to pursue its political agenda.

According to the statement, if Georgian Dream achieves a constitutional majority, it plans to initiate legal processes aimed at declaring the opposition parties, particularly the United National Movement (UNM) and its affiliates, unconstitutional. The statement warned, "As soon as the constitutional majority is obtained, a legal process will be initiated, as a result of which the United National Movement and all its satellite or successor parties will be declared unconstitutional."

Prime Minister Irakli Kobakhidze supported the party's stance, framing the potential banning of political parties as a democratic process. He argued that such actions are justified when there is a legal basis, stating, "When there is a legal basis, it should be done in a democratic state."

Kobakhidze compared the situation to party bans in Ukraine and Moldova, stating that these actions were positively evaluated by the European Union. "Saakashvili's regime is



not a Georgian state. We are talking about the trial of Saakashvili's regime, and of course, this process cannot pose any threat to our national inter-

ests," Kobakhidze said.

He further justified the potential banning of what he described as "illegitimate, unconstitutional" parties by saying, "This

is a normal democratic procedure, when all legal grounds are in place. When a political party creates problems for the national interests of the state, or is anti-

constitutional, anti-democratic in its content, its ban is the responsibility of the state to uphold its democratic system."

Public Defender of Georgia Meets with Striking Employees of Evolution Georgia

Public Defender of Georgia Levan Ioseliani and Deputy Public Defender Irine Chikhladze recently met with striking employees of Evolution Georgia LLC to discuss their ongoing labor dispute. The meeting, aimed at addressing the workers' concerns, was reported by the Public Defender's office.

The strikers, who have been on strike since July 12, high-lighted several serious issues, including violations of labor rights, unhygienic and health-threatening working conditions, and degrading treatment by management. Additionally, four of the strikers are on a hunger strike, with one having undergone lip sewing as a form of protect.

Levan Ioseliani acknowledged that the issues raised are deeply tied to labor conditions and the enforcement of labor norms. However, he noted that the Public Defender's office, due to its limited mandate over the private sector, does not have the authority to mediate the dispute directly. "Each issue in this collective labor dispute is directly related to labor conditions and the effective use of labor norms. Given our limited mandate, we are unable to lead the mediation process," Ioseliani said.

The Public Defender's office has called on Evolution Georgia to comply with labor legislation and engage in timely and effective conciliation procedures with the striking employees. Ioseliani emphasized, "From the first day of the protest, we began examining their issues on our own initiative and have issued several public statements urging both the employer and the labor

Public Defender Levan **Ioseliani to File Friend** of the Court Brief in 'Foreign Agents' Law Case

regarding the "Foreign Agents" law. The brief aims to provide additional legal perspectives and insights to assist the court in its deliberations.

Ioseliani explained, "What we've really decided at this point is that we're going to file a friend-of-the-court opinion that will be attached to the lawsuits,

to absolutely every lawsuit filed in court. This is not an opinion presented in favor of any party; it is a document created in accordance with international standards, which responds to the court in making a more correct decision and makes it easier to find and justify legal argu-

The lawsuits against the "Foreign Agents" law have been filed by the President, 121 non-governmental and media organizations, and opposition deputies. Additionally, Gela Mtivlishvili, founder and editor of Mtis Ambebi, has independently appealed to the Constitutional Court.

The plaintiffs are seeking a temporary suspension of the law until the court issues a final decision. On July 29, Constitutional Court Chairman Merab Turava announced that all the lawsuits would be consolidated into one proceeding.

Training on intelligence-led policing for Ukrainian law enforcement



The European Union Advi sory Mission (EUAM) Ukraine recently organised a two-week training on intelligence-led policing (ILP) in War-

saw for Ukrainian analysts from the National Police of Ukraine, the Economic Security Bureau of Ukraine, and academic institutions under the Ministry of Internal Affairs.

Intelligence-led policing serves as the cornerstone of modlaw enforcement, emphasising proactive and preventative strategies over reactive measures. This approach ensures that police forces remain "one step ahead" of criminal activity. For ILP to be effective, the information gathered by police must be carefully collected, collated, thoroughly analysed, and effectively disseminated. This systematic process, which is also known as an Intelligence Cycle, allows law enforcement to respond appropriately and allocate resources where they are most needed.

The training was designed to equip participants with essential

skills in intelligence analysis. It provided an in-depth exploration of the Intelligence Cycle, practical application of 20 Structured Analytical Techniques, and a thorough understanding of the analytic spectrum.

Participants reported a broader understanding of analytical techniques and an improved ability to apply these methods, especially in generating and testing hypotheses and scenarios, foreseen through teamwork.

EUAM Ukraine continues to support law enforcement agencies in Ukraine, including in the realm of intelligence-led policing, particularly evidence-based decisionmaking via thorough analysis.

Festival "Night Serenades"

This year marks the 16th edition of the festival since its renewal and will be held in three cities: Borjomi, Batumi, and Tbilisi.

The festival opening took place on August 21, with an open-air gala concert in Borjomi at Borjomi Likani Hotel.

On August 23, at 8:00 PM, Batumi Professional State Drama Theater will host Mario Stefano Pietrodarchi (Bandoneon, Italy) and the festival Base Orchestra (concertmaster Lela Mtchedlidze). They will perform masterpieces of world-renowned composers: Ennio Morricone – Three themes, Nino Rota – Ommagio a Federico Fellini, Khaled Mouzanar – Medley, Carlos Gardel – Volver; Por una Cabeza, Astor Piazzolla – Melodia in La minore; Adios

Nonino; Vuelvo al Sur; Milonga del Angel; Le, Grand Tango.

On the second day of the festival, August 25 at 8:00 PM, Batumi Ilia Chavchavadze theater will host Elvin Hoxha Ganiyev – Violin, Azerbaijan / Turkey and the Festival Base Orchestra GEORGIAN VIRTUOSI (concertmaster Lela Mtchedlidze). The concert program includes Antonio Vivaldi's "The Four Seasons," Astor Piazzolla's "The Four Seasons of Buenos Aires," and Niccolò Paganini's "Caprice No. 24."

Starting September 15, "Night Serenades" will proceed to Tbilisi. Beatrice Venezi (conductor, Italy), Sandro Nebieridze (piano, Georgia), and Georgian Philharmonic Orchestra will perform Ottorino Respighi's "Pines of Rome" and

Sergei Rachmaninoff's Piano Concerto No. 3 in D minor, Op. 30.

On September 17 at 8:00 PM, an evening of Brazilian music will take place at Tbilisi State Conservatoire Grand Hall. The concert will feature young, renowned Georgian soloists Lizi Ramishvili (cello), Mariam Roinishvili (soprano) and Giorgi Oikashvili (clarinet), with the Festival Base Orchestra GEORGIAN VIRTUOSI led by first violinist Lela Mtchedlidze. The program includes works by Brazilian composers such as Alberto Nepomuceno's String Quartet No. 3 "Brasileiro," Heitor Villa-Lobos' Five Songs, Chiquinha Gonzaga's "Corta Jaca," Zequinha de Abreu's "Tico-Tico no Fubá," etc.

"Night Serenades" will also feature a Czech music concert on September 18 at 6:00 PM at Recital Hall of Tbilisi State Conservatoire. In celebration of the 200th anniversary of Bedøich Smetana, Giorgi Shaverzashvili (piano, Georgia) and Giorgi Khaindrava (violin, Georgia) will perform works by Bedøich Smetana and Antonín Dvoøák. Attendees can look forward to many musical surprises throughout the concert.

This year's festival will be wrapped up on September 20 at 8:00 PM at Tbilisi State Conservatoire Grand Hall. Andres Gabetta – Violin / Conductor, France and Maurice Steger – Recorder, Switzerland with Festival Base Orchestra GEORGIAN VIRTUOSI (concertmaster Lela Mtchedlidze) will perform special program VIVALDI and Friends. The concert program includes: Evaristo Felice DallAbaco's – Concerto a più istrumenti in D major, Op.5 No.6 – Ciaconna, Pietro Locatelli – Concerto Grosso in C minor, Op.1 No.11, and concertos of Greatest Master Antonio Vivaldi.

Along with the concert program, within the framework of the festival, special attention will be paid to the cognitive-educational program for students and young people, including the disabled people, which includes master classes, workshops, open lectures and traditionally exhibitions by Georgian artists.

It is worth mentioning that Georgian violinist and conductor, the founder of the festival, Liana Isakadze passed away on July 5, 2024 at the age of 77. As well as a prominent soloist in Georgia, she conducted the Georgian State Chamber Orchestra and in 1988 was recognized as a People's Artist of the USSR, at the time the youngest artist to be so named.
