Zourabichvili Urges Constitutional Court to Address Election Violations Amid Political Crisis

President Salome Zourabichvili has stated that in the coming days, the most crucial matter will be for the Constitutional Court to begin reviewing the appeal filed regarding election violations. Zourabichvili made this remark after meeting with parties that have signed the Georgian Charter.

According to Zourabichvili, the Constitutional Court now has a unique opportunity to resolve the country's political crisis.

"As for the direction political parties and society are collectively heading, what has become clear today and will become even clearer in the coming period as we hold further meetings, is that we are not only remaining within the constitutional framework, but the first step and action, which must begin even this evening, is to exert pressure on the Constitutional Court. The Constitutional Court and its judges have an extraordinary and historically unique opportunity to resolve this deep national



crisis within the political and constitutional framework, a crisis whose direction and outcome remain uncertain.

Instead of taking action, the Constitutional Court has not yet

even scheduled a hearing.

Thus, the efforts of political parties, society, activists, judges, and lawyers in the coming days must focus on ensuring that a hearing is scheduled and that

the Constitutional Court reviews the appeal. A positive resolution of this matter will return us to a constitutional framework," Zourabichvili stated.

On November 19, President

Salome Zourabichvili submitted an appeal to the Constitutional Court regarding violations of the principles of electoral secrecy and universality.

Tensions Rise as Protesters Demand Changes at Georgian Public Broadcaster

On December 1, protests in front of the Georgian Public Broadcaster (GBP) intensified as demonstrators blocked traffic after the channel's leadership refused to meet with them. The protesters, calling for the resignation of GBP's Director Tinatin Berdzenishvili and Board Chair Vasil Maglaperidze, demanded

that the broadcaster provide equal airtime for opposition leaders and President Salome Zourabichvili. GBP responded by stating that it was willing to allow President Zourabichvili to speak "even today."

The conflict between the GBP and the protesters escalated after the channel issued an official statement, accusing opposition TV channels of putting "unprec-

edented pressure" on the broadcaster, which it said hindered its ability to perform its duties. The GBP also condemned the use of violence and disproportionate force against journalists during the protests, calling on authorities to investigate and ensure journalists' safety.

This protest follows months of growing discontent over what many see as the GBP's biased coverage, with accusations that it predominantly airs content favoring the ruling Georgian Dream party. Maglaperidze, a former deputy chair of Georgian Dream, has faced criticism for his role in allegedly censoring opposition voices.

Earlier on November 30, journalists and activists had camped outside the GBP building, demanding that the channel broadcast a broader spectrum of political opinions. This led to a special live broadcast where opposition figures, journalists, and ordinary citizens involved in the protests spoke out.

The GBP is publicly funded, with an annual budget allocation of GEL 110.3 million for 2024. Tensions between the broadcaster and the ruling party flared in November 2023 over changes to its funding scheme, although the issue was later resolved. Despite these efforts, accusations of censorship and government bias remain a significant issue for the channel, especially amidst the ongoing protests.

On November 29, U.S. Helsinki Commission Chairman Rep. Joe Wilson and Ranking Member Rep. Steve Cohen issued a statement in support of Georgian citizens who have been protesting against the Georgian Dream (GD) party's decision to suspend the country's European Union accession process. The statement condemned the violence directed at peaceful protestors, emphasizing that "those peaceful protests were met with extreme violence," which the representatives condemned "in the harshest terms possible."

The statement also highlighted concerns over the legitimacy of the Georgian government, pointing to evidence that the GD government manipulated the country's October elections to maintain its hold on power and obstruct the Georgian people's "unequivocal aspirations for Euro-Atlantic integration". Wilson and

They concluded their statement by calling for the U.S. State Department to hold accountable those responsible for violating the right to peacefully protest and elect leaders.

GYLA Reports Over 200 **Arrests and Violations During** Tbilisi Protests Against Georgian Dream's **EU** Suspension

The Georgian Young Lawyers' Association (GYLA) reported over 200 arrests during protests in Tbilisi from November 28 to December 1, following the Geor-



GYLA's statement highlighted disturbing conditions during the protests, including reports of police brutality, psychological violence, and a lack of adequate medical care for detainees. Additionally, many detainees reported the theft or loss of personal belongings, including mobile all detainees, the cessation of proceedings against them, and full legal protection of detainees' rights. The organization emphasized the need for lawyers to have full access to their clients and for detainees to receive appropriate medical treatment.
