eorgia's Public Defender, GLevan Ioseliani, has raised serious concerns about alleged violence and inhumane treatment of detainees arrested during recent protests. According to Ioseliani, 124 out of 156 individuals-nearly 80%-claimed they were subjected to excessive force by police.

"This is a very disturbing number," Ioseliani stated. "If we look at the dynamics, including previous demonstrations, the number of citizens who claim that there was an excess of force on the part of the police is increasing alarmingly. I once again call on the police not to go beyond the norms established by the law and to use only legitimate force against citizens.'

Ioseliani criticized what he described as a culture of impunity within law enforcement, warning that unchecked misconduct fosters escalating brutality. "When specific people are not punished for such misdemeanors, it becomes more and more brutal," he said.

He expressed particular outrage over attacks on journalists covering the protests, calling such incidents "monstrous." "It is unimaginable to treat people like this, to attack them - especially journalists who are doing their duty and reporting information, which is their constitutional right," Ioseliani remarked.

NGOs Demand Accountability for Police Violence Against Peaceful Protesters

on-governmental organiza tions (NGOs) have strongly condemned the crackdown on peaceful demonstrators by police forces during recent protests in Georgia. The NGOs allege widerights, including inhumane unconstitutional, and illegititreatment, illegal detentions, and targeted attacks on journalists, actions they describe as unconstitutional and incompatible with international law.

The organizations claim that the Georgian government, which

istic activity, and promptly submit findings to the Prosecutor's Office.

Prosecutor's Office: Oversee investigations effectively, prosecute perpetrators, and review the legality of arrests. Judiciary: Stop using legal mechanisms for punitive actions against peaceful protesters and ensure justice for victims.

Constitutional Court: Declare elections invalid due to alleged procedural violations and secrecy surrounding the process.

He urged those who have remained

"Pre-detention isolators are overcrowded, and some detainees spend nights in vehicles," he said. Gakharia further alleged that numerous detainees leave detention facilities with injuries resulting from physical violence.

He called on the public to demand the release of those he described as "illegally detained," stating, "The state is physically abusing them."

Top EU officials visit Kyiv on their first day in office

On 1 December, on their very first day in office, the new Head of the European Council António Costa, together with the EU High Representative and Vice President of the European Comgovernment's framing of the protests as a "Ukrainian scenario" and accused it of implementing a "Belarusian scenario", eroding democratic norms while intimidating citizens. Ukraine also expressed solidarity with

Georgian diplomats who opposed the government's decision to suspend EU talks. "In 2004 and 2014, Ukrainian diplomats stood for democracy during critical times. We recognize the courage of Georgian colleagues now doing the same," the statement said.

Ukraine reaffirmed its commitment to

a just and lasting peace". This visit was also planned to

mark the anniversary of Ukraine's independence referendum, which took place on 1 December 1991.

At a joint press conference with President Volodymyr Zelenskyy, António Costa, who previously served as a Prime Minister of Portugal, told journalists that this visit, on this particular day, had a very special meaning for him. "On the first

of December, for almost 400 years, every single year, my own country celebrates its independence day: our national sovereignty, the right to self-determination, the right of territorial integrity and respect for its borders. Ukraine, like my country, like all countries in the world, has the same right under the

He also announced that the European Union and Ukraine will work to open at least two clusters of negotiations on Ukraine's accession to the EU during the first half of next year.
