VICTORY TROPHY FOR RED TERROR

The Heckler and Koch MP5 is an automatic weapon developed in 1966 by the world famous German munitions maker. It is the most widely used automatic weapon in the world, adopted by military, intelligence, security and law enforcement organizations in over fifty nations. It achieved iconic status in 1980 when the British Special Air Service used it to storm the Iranian Embassy in London, rescuing the hostages and killing the five Iranian terrorists inside. Superimposed on a five pointed red star and beneath the letters RAF, it formed part of a terrifying logo. This was the logo of an organization which terrorized Germany for thirty years. The Red Army Faction, founded in 1970 by Andreas Baader, Ulrike Meinhof, Gudrun Ennslin and Horst Mahler, was a machine spraying out of its Heckler and Koch MP5s the eternal message of Marxism, a message broadcast from the first day of its founding in the nineteenth century: a message of bombings, assassinations, kidnappings, riots, bank robberies and shoot outs with the police. Rejecting reason and the senses, which present a world of separate individuals in space and time, a world sane people have perceived and understood for thousands of years, the dark religion of Marxism, the darkest religion known to mankind, exalts a netherworld of mysticism. It is a religion which justifies murder and mayhem and appeals to those with criminal propensities. It is a religion of aggression for the sake of aggression and power for the sake of power. It is a religion made by and for those who lack morality, empathy, remorse and conscience, by those who scale peaks of euphoria and achieve the release of all tension when they deprive innocent people of their rights. It is a religion which has done something no religion has ever done before in the history of mankind, something as simple and stark as it is brutal and inhuman: it has given voice and expression to those who find acts of hurting, damaging and killing someone or something exciting. Exploding out of the barrels of the Heckler and Koch MP5 and its facsimiles, it is a sanity defying, imagination defying, rationally incomprehensible pornography of violence. The story of Marxism is the story of the mutations of a monster. The enjoyment of destruction under the banner of class logically gave rise to other psychopathic impulses which would together exhaust the gamut of crime. It gave rise to the enjoyment of destruction under the banner of race and the enjoyment of destruction under the banner of gender. From these three impulses, a new nightmare creature emerged in the 1960s, a creature emanating unspeakable evil and ugliness, a creature with three heads, breathing the fires of gender war, race war and class war, and this triple headed, neoMarxist monster, marked gender, race and class politics, went on a rampage and starting attacking males, whites, and successful people, and in the twenty first century, has drowned the world in rivers of at its story and see the story of civilization in its final stages dissolution. Even in Africa, a ballpark figure for nations

celebrating Kwanzaa could be zero." (*Domestic Terrorism History Month* by Lloyd Billingsley). Her grandfather was William Randolph Hearst, creator of a media empire, the largest newspaper, magazine, newsreel and film business in the world. In 1974, Patricia Hearst joined the Symbionese Liberation Army. Adopting the name Tania, in honor of Che Guevara's comrade Tania the Guerrilla, she took up an MI Carbine and robbed the Sunset District branch of the Hibernia Bank in San Franscisco: "I'm Tania. Up, up, up against the wall, motherfuckers!" Affecting the rich and powerful and the poor and weak, communism is a moral disease afflicting every group in society locked in a state of degeneration, and it has consumed and buried the West. Its program is rejection, the rejection of knowledge, morality and human purpose, and it has composed the sorry epitaph of civilization in the twenty first century.

RED TRANSIT ROLLS THROUGH LUXEMBOURG

Its capital city is one of the capitals of the European Union, together with Brussels, Frankfurt and Strasbourg. It is the seat of major European Union institutions, such as the European Investment Bank, the European Court of Auditors, and the European Court of Justice, which is the supreme judicial body of the EU. It is the richest country in the world, with a per capita GDP of \$140,000 and household wealth of one million dollars. It occupies the top ranks of the Heritage Foundation's Index of Economic Freedom, the United Nations' Human Development Index, the *Economist* Intelligence Unit's quality of life index, and the Global Innovation Index, published by the World Intellectual Property Organization. Its industrial sector, dominated by steel production, was swept away in the 1980s because it could not compete with the more productive Asian nations, and was replaced by a financial services sector, specializing in providing tax havens, tax loopholes, private banking and investment funds. On February 29, 2020, this tiny, landlocked nation known as Luxembourg gave civilized people throughout the world an education they will never forget. It gave them a picture they had seen only in their nightmares. It gave them a terrifying vision of the shape of things to come and sent them reeling back in horror and running for their lives. On February 29, 2020, this global financial center and banking hub illustrated in stark, dramatic terms how far the moral cancer on the West had advanced. It had advanced to claim a center of European civilization, a capital of the European Union and an advertisement of successful capitalist development. This cancer has been diagnosed by civilized people as communism and it has spared no nation, no society, no class, high or low, rich or power, in it relentless advance to enslave mankind. Rejecting the values of the West's shining Enlightenment, the values of reason, sanity, science and human flourishing, this cancer has been fueled by mass ovations given by the unholy mobs who have taken charge of civilization during its twilight stage and plunged it into a mad vortex of state violence. On February 29, 2020, this cancer struck Luxembourg and laid it low. On this day, this country made history and skyrocketed to the top of the annals of infamy. On this day, the bells, whistles, wheels and rolling stock of communism were set down upon the nation. On this day, Luxembourg became the first country in the world to establish no charge public transportation. The nightmare of the former communist bloc returned to Europe, descended on Luxembourg, and transformed free citizens into coerced comrades of the cause of human enslavement. Through the communist way, through the way of state tax robbery, through the way of forcing Peter to subsidize Paul, and through the way of dragooning free people into an iron net marked social responsibility, Luxembourg has filled a communal swampland on cables and wheels in which transport on trains, buses, trams and funiculars is paid for by the state and passengers ride for free. Look at Luxembourg today and see state violence against private wealth proclaimed to be pleasant, attractive and an expression of benevolence, and see a shining symbol of European freedom transformed into a social justice leviathan: "Although free transport has not yet fulfilled its practical purpose, it is a nice and true advertisement for Luxembourg as a social justice state, where everyone has the right to affordable

travel." (Why Public Transport Is Free In Luxembourg by Sergey Ves and Daria Saltykova). Look at Luxembourg today and see communist transport justified in the name of reducing traffic congestion. See communist transport justified in the name of reducing greenhouse gas emissions. See the proclamation that the poor have a right to transport paid for by the rich. See the proclamation that individuals earning high wages have a duty to pay for the transport of those who earn low wages. See the proclamation that Luxembourg, as a wealthy nation, must be plundered by the state to provide free transport to the mobs. See communist transport justified in the name of alleviating poverty. See communist transport justified in the name of helping pensioners. See a national campaign to remove private automobiles from the roads and push the people at gunpoint into the mobile death vans of communist public works: "Over the past four decades Luxembourg's population has increased by almost 240,000 people. The labor force has grown from 161,000 in 1998 to 427,000 in 2018, fueled in part by a 168 percent rise in cross border workers. Today, the Grand Duchy has the highest number of passenger cars per inhabitant in the EU (including company cars registered there used by nonresident cross border workers). More than sixty percent of commuters use their cars to get to work, compared to just nineteen percent who use public transport. Yet cutting congestion and improving the environment are not the main drivers of the free public transport initiative, according to minister for mobility and public works Francois Bausch. 'It is primarily a social measure,' he says. 'The objective is to stop the deepening gap between rich and poor. For people on low wages, transport expenses matter. Therefore it is easier to make it free for everyone.' Luxembourg is widely seen as a wealthy nation-it has the highest average annual salary of all OECD countries. But poverty is increasing: the bottom ten percent live on an average of 1,011 euros (£878, \$1,144) per month, according to Luxembourg's statistics office. Thirteen percent of workers and almost ten percent of pensioner are at risk of poverty. Free public transport is one of several pieces of social legislation the recently reelected government is keen to pass in 2019, including raising the minimum wage, pension adjustments and financial aid for higher education. 'Free transport is an awesome idea,' says M'Barek Rabii. He works at La Provencale, the national wholesale market hall. Divorced with a twelve year old child, he earns the legal minimum wage. From his after tax monthly salary of 1,770 euros (£1,540), he spends around 900 euros on rent and fifty euros on public transport each month, explaining he cannot afford to buy the 400 euro season ticket. 'Together with the minimum wage increase, it will help people with low salaries like me to better make ends meet,' he believes. But persuading car drivers to jump on board free trains and buses may be a difficult proposition, given many see the public transport system as clunky and inconvenient." (The Cost Of Luxembourg's Free Public Transport Plan by Marc Auxenfants). Look at Luxembourg today and see communist transport justified in the name of preventing climate doomsday brought by global warming. Luxembourg recently celebrated three years of free public transport. And, according to the people who live there, it has been a resounding success. As countries look to encourage citizens to ditch their cars to cut carbon emissions, could Luxembourg's success be replicated across Europe? Bausch explains that the country decided to make public transport free for two reasons: to give everyone fair access and to encourage debate and awareness around a decade of change in its mobility system. Back in 2013 when Bausch first took up his position, rush hour traffic jams were a daily occurrence in Luxembourg city center.

Now there are none thanks to the increased use of the tram system and a reorganization of the way its streets work. The tram has exclusive right of way and has priority at crossings so is never stuck in traffic jams. This combined with the fact that it's free encourages more people to use it. Bausch sees it as a measure of the success of Luxembourg's transport transformation. Public transport in Luxembourg isn't really free for most people. 'Obviously it is paid through general taxation. People who pay more taxes in fact do not have free access to transport; they pay indirectly through their taxes,' says Bausch. 'But those who, for example, earn nothing or very little, they are the ones who pay no taxes or very few direct taxes, and they really get it for free.' " (Europe's Richest Country Made Public Transport Free: Could Other Countries Do The Same? by Hannah Brown). In today's world in which goods, services, talents and capital are mobile without restraint, a nation's branding, image and reputation are vital to its development. Proclaiming that zero fare, state subsidized, mass transit is "an important social measure", Luxembourg has rebranded itself in the twenty first century. The new Luxembourg brand, supported by standing ovations of the people: Made In Russia.

GLOBAL CALIPHATE LANDS ON BRITISH SHORES

It gave the modern world freedom. After the Roman Empire, it ruled the greatest empire of freedom the world had ever seen. See it reduce the Labor and Conservative parties to its helpless marionettes. See it shift millions of votes to the cause of totalitarian tyranny. See it make the oppression of the Jews, infidels and the female population a national policy. See it breach the separation of church and state with the cannons of sectarian politics. See it elect as members of parliament rabid fanatics foaming at the mouth dedicated to the overthrow of Western Enlightenment. See it transform a free nation into a religious bloc encircled by an iron curtain. See it replace the nation's traditional concern with advancing human welfare with the aim of advancing mystical welfare. See it transform a nation which for centuries had prospered by encouraging the progress of science into a failed nation which worships at the altars of ignorance and superstition. See it Islamize the founder of Western liberal history and incinerate the moral map of Europe. See it destroy the nation's thousand year old culture and identity of freedom and establish in their place massive, organized support for a regime of psychopathic violence marching under the banners of the Star and Crescent. See it provide all forms of support, technical support, volunteers, marketing, funding, legal advice and polling data, to a movement which has declared holy war against the survival and success of modernity. See a parliament, a legal system, an educational system, an economic system and megaphones of the mass media, which for centuries had given voice and expression to the noonday world of reason and sanity, placed in the service of a movement founded on faith, force, supernaturalism and a return to the Dark Ages: "In recent weeks and months, while the streets of Britain's cities have been packed with angry Muslims protesting the government's proIsrael stance, Labor politicians who have previously relied on Muslim votes have been wringing their hands over polls showing that they can no longer count on Muslim support. According to a new survey by the Labor Muslim Network, just sixty percent of British Muslims who voted for Labor in 2019 say they'll do the same in this year's general election. Earlier this month, former Tory Prime Minister David Cameron, who is currently Foreign Minister, shook things up by suggesting that the UK might be prepared to recognize a Palestinian state—an action that might well shift a great many Muslim votes to the Conservatives. Now comes the news that certain members of Britain's four million strong Muslim community-with support from the Muslim Association of Britain, the Muslim Council of Scotland, the Muslim Council of Wales, the Council of Sri Lankan Muslim Organizations, and over a dozen other such organizations-have come together to wage a self described 'community campaign.' And what are its goals? There are, after all, many worthy goals to choose from. British Muslims might have joined forces to address the involvement of Muslim youths in grooming gangs-or, more broadly, in violent crime generally. They might have formed a movement to combat religious extremism and to teach newly arrived Muslims about Western democratic values. They might have made it their goal to liberate women and girls from their subordinate status in many Muslim homes-and, specifically, to fight such offenses as honor killing and forced marriage. But no, these British Muslims have formed something called The Muslim Vote, the objective of which is easily and briefly stated. In fact, you can express it in a single word: power. Nigel Farage, addressing this new development on GB News, called it 'the beginning of sectarian politics' in the UK (not counting Northern Ireland during The Troubles). He noted that while Hindus, Sikhs, and blacks in Britain tend not to vote in blocs, Muslims-in this as in so many other ways-are another matter, and he worried that The Muslim Vote might facilitate the election of new MPs whose agenda will be entirely about pushing for appearement of Islam. (Listening to Farage, it was to be reminded of Ilhan Omar's recent declaration, before a Somali-American audience, that as a member of Congress she is dedicated wholly not to the welfare of her constituents, let alone to her adopted country, but rather to improving the fortunes of the failed nation of her birth.) Farage's guest on this particular GB News segment, a former Labor Party advisor named Scarlett McGwire, dismissed his concerns, predicting that The Muslim Vote wouldn't 'go anywhere.' (Funny, isn't it, how, throughout the history

of the Islamization of Western Europe, there have always been prominent people who are quick to brush off concerns about the direction in which things are obviously going.) By contrast, Aletha Adu of The Guardian told another GB News host, Patrick Christys, that The Muslim Vote is 'going to be huge,' while Jonathan Gullis, a Conservative MP representing Stoke on Trent, predicted that the group would be 'massively influential' in constituencies like his." (A Step Forward For Islamic Influence In Britain? by Bruce Bawer). Thirty thousand year ago, Britain was settled and ruled by Cro-Magnon man. Five thousand years ago, Stonehenge was built on Salisbury Plain in southern England. Action: Soviet leader Joseph Stalin and German Foreign Minister Joachim von Ribbentrop sign the Treaty of Non Aggression between Germany and the Union of Soviet Socialist Republics, a nonaggression pact between Germany and the Soviet Union, with a secret agreement which partitioned Eastern Europe between the two nations. This was a natural and inevitable treaty between two totalitarian powers bent on world domination which confronted a common enemy. The common enemy was a free society and these powers made common cause to destroy it, after which they would fight over the spoils. Two totalitarian nations, one, the Soviet Union, leading a global class war against freedom, while the other, the Third Reich, leading a global race war against freedom, which joined forces to form a terrifying pincer movement which would encircle and strangle freedom and close off the story of civilization. Two totalitarian nations, both sworn enemies of the Age of Enlightenment, both dedicated to the proposition that man is not a rational, free born agent but is born into a state of slavery, that the individual has no right to live and work for himself, and only differing between themselves with respect to the color of the lash wielded against the innocent. (Germany: More Demos Against Far Right, Deutsche Welle, February 18, 2024). On August 22, 1939, Joachim von Ribbentrop flew from Berlin to Moscow. Inside the Kremlin, he shook hands with Joseph Stalin. He signed a nonaggression pact with Stalin which placed Eastern Europe on the carving block. In the twenty first century, the Kremlin has been reconstituted in Berlin. Inside it, two movements have met and shaken hands. Marxists and Islamists have signed a nonaggression pact and carved up the free world.

EDWARD SAID BEHIND THE SCENES

Franciscan friar renowned for his gray robes, he never achieved the rank of cardinal But exercised great influence over Richelieu, and because of his attire was popularly known as His Gray Eminence. Furthermore, it hardly needs saying that because the Middle East is now so identified with Great Power politics, oil economics, and the simple minded dichotomy of freedom loving, democratic Israel and evil, totalitarian, and terroristic Arabs, the chances of anything like a clear view of what one talks about in talking about the Near East are depressingly small." (Orientalism by Edward Said). Listen to the creed of Edward Said. He proclaims that bigotry, intolerance, pseudoscholarship and blind, unreasoning hatred are defined by the following. Condemnation of the Arab world for what it is: a cult of mindless conformity. Condemnation of the Islamist world for what it is: a wilderness of religious submission. Condemnation of the East for what it is: a sealed capsule of unenlightenment and unknowing. Condemnation of the East for what it is: a regime of clients and patrons, lords and serfs. Condemnation of the East for what it is: a regime of raw power and domination. Condemnation of the East for what it is: a regime in which the peaceful, the law abiding and the nonaggressive incur public shame and opprobrium. Condemnation of the East for what it is: a regime in which ruthless robbers, killers and enforcers enjoy public respect and admiration. Condemnation of the East for what it is: a regime of brute, unending, animal feuds and vengeance. Condemnation of the East for what it is: a regime which worships war and hostility as the highest form of human relations. Condemnation of the East for what it is: a regime which sacrifices morality on the altar of success, expediency and the principle that the end justifies the means. Condemnation of the East for what it is: a regime which exalts raiding and plundering above production and exchange. Condemnation of the East for what it is: a regime which demands obedience and solidarity at the

expense of individual freedom and autonomy. Condemnation of the East for what it is: a regime which exalts deceit, dishonesty, subterfuge and treachery. Condemnation of the East for what it is: a regime in which all are suspicious of all, all are distrustful of all, and all are ready to kill all. Condemnation of the East for what it is: a regime in which the state, society and the economy are predicated on the will to power of clans, tribes, mosques and beasts of prey: "In its February 1972 issue, the American Journal of Psychiatry printed an essay by Harold W. Glidden, who is identified as a retired member of the Bureau of Intelligence and Research, United States Department of State; the essay's title (The Arab World), its tone, and its content argue a highly characteristic Orientalist bent of mind. Thus for his four page, double columned psychological portrait of over 100 million people, considered for a period of 1,300 years, Glidden cites exactly four sources for his views: a recent book on Tripoli, one issue of the Egyptian newspaper Al-Ahram, the periodical Oriente Moderno, and a book by Majid Khadduri, a well known Orientalist. The article itself purports to uncover 'the inner workings of Arab behavior,' which from our point of view is 'aberrant' but for Arabs is 'normal'. After this auspicious start, we are told that Arabs stress conformity; that Arabs inhabit a shame culture whose 'prestige system' involves the ability to attract followers and clients (as an aside we are told that 'Arab society is and always has been based on a system of client-patron relationships'); that Arabs can function only in conflict situations; that prestige is based solely on the ability to dominate others; that a shame culture—and therefore Islam itself—makes a virtue of revenge; that if from a Western point of view 'the only rational thing for the Arabs to do is to make peace for the Arabs the situation is not governed by this kind of logic, for objectivity is not a value in the Arab system.' " (Orientalism by Edward Said). In 1873, the world famous French painter, Jean Leon Gerome, created his masterpiece, L'Eminence Grise. It depicts François Leclerc du Tremblay descending the grand staircase of the *Palais Cardinal* and the deference shown to this gray robed figure who wielded power behind the scenes. In the twenty first century, Jean Leon Gerome's masterpiece has been repainted with a new character. He is the gray eminence behind a movement opposed to the Enlightenment and the institutions of a free society. degeneration they represent hurled Classical civilization into the dustbin of history and has presently destroyed the West. Symptoms of degeneration leading to the rejection of reason, sanity, common sense and ordinary experience, they are comprised of a movement which rejects the primacy of matter and places primacy in a supernatural realm of the pure spirit, and a movement which rejects the existence of spirit altogether and reduces man to the level of an animal. Listen to the Supreme Court declare that a zygote is not a zygote but is an unborn human being: "What sharply distinguishes the abortion right from the rights recognized in the cases on which *Roe* and *Casey* rely is something that both those decisions acknowledged: Abortion destroys what those decisions call potential life and what the law at issue in this case regards as the life of an unborn human being." (Dobbs vs Jackson Women's Health Organization, decided June 24, 2022, Associate Justice Samuel Alito delivering the opinion of the Court). Listen to the Supreme Court declare that words do not mean what they mean, the constitutional text does not say what it says, and the right to liberty does not mean the right to liberty: "That provision [the Due Process Clause of the Fourteenth Amendment has been held to guarantee some rights that are not mentioned in the Constitution, but any such right must be 'deeply rooted in this Nation's history and tradition' and 'implicit in the concept of ordered liberty.' " (Dobbs vs Jackson Women's Health Organization, decided June 24, 2022, Associate Justice Samuel Alito delivering the opinion of the Court). Listen to the Supreme Court bang the gavel and dismiss the First Amendment, and usher in the Christian Dark Ages in America: "The Constitution does not confer a right to abortion. Roe and Casey are overruled. The authority to regulate abortion is returned to the people and their elected representatives." (Dobbs vs Jackson Women's Health Organization, decided June 24, 2022, Associate Justice Samuel Alito delivering the opinion of the Court). The Supreme Court's decision unleashed a torrent of Christian activism in courts and legislatures throughout the nation which tolled the death bell for the First

Amendment. Look at Alabama and see its legislature proclaim that abortion is murder and enact a ban on abortion at all stages of pregnancy. See its Supreme Court proclaim that embryos are unborn children. See it proclaim that embryos are persons entitled to full protection under the law. See it proclaim that embryos are minors and their destruction represents wrongful death. See it proclaim that embryos and fetuses must be legally considered to be persons. See it proclaim that human life commences at the moment of conception. See it proclaim that fertilized eggs are people. See it proclaim that the legal protection of zygotes represents a victory for life. See it proclaim that God is the source of all glory, truth and reality and has decreed that human personhood mystically appears when a sperm fuses with an egg: "A ruling from the Alabama Supreme Court that frozen embryos are considered children, and that a person could be held liable for accidentally destroying them, has opened up a new front in the US battle over reproductive medicine. The decision has thrown the future of IVF treatments in the state into doubt, with a host of healthcare providers in the state suspending the service. Medical experts and reproductive advocacy groups warned the ruling could have negative consequences for fertility treatments in Alabama and beyond. Some antiabortion groups applauded the ruling, arguing that embryos deserve greater legal protections. The case stems from a wrongful death lawsuit brought by three couples whose embryos were lost at a fertility clinic in 2020. A patient had wandered into the place where the embryos were stored, handled them, and accidentally dropped them. As a result, the embryos were destroyed. The couples sought to sue the Center for Reproductive Medicine and the Mobile Infirmary Association under the state's Wrongful Death of a Minor Act. That law covers fetuses, but did not specifically cover embryos resulting from IVF. A lower court had ruled that the embryos did not qualify as a person or child, and that a wrongful death lawsuit could not move forward. But in its ruling, the Alabama Supreme Court sided with the couples, and ruled that frozen embryos were considered children. The wrongful death law applied to 'all unborn children, regardless of their location', the decision said. Concurring with the majority opinion, Chief Justice Tom Parker wrote: 'Even before birth, all human beings have the image of God, and their lives cannot be destroyed without effacing his glory.' Elisabeth Smith, director of state policy at the Center for Reproductive Rights, told the BBC in a statement: 'Not all [IVF] embryos are used, nor can they be. To enact legislation granting legal personhood to embryos could have disastrous consequences for the use of IVF--a science many people rely on to build their families.' When the US Supreme Court struck down a nationwide right to abortion in 2022, it opened the door for states to make their own laws on the issue. Alabama already has a total ban on abortion, at all stages of pregnancy. The question of when an embryo or a fetus is legally considered a person is a factor in many state abortion restrictions. The Alliance Defending Freedom, a conservative Christian legal group, described the Alabama ruling as a 'tremendous victory for life'. 'No matter the circumstances, all human life is valuable from the moment of conception,' spokeswoman Denise Burke said in a statement to the BBC. 'We are grateful the Court correctly found that Alabama law recognizes this fundamental truth.' Eric Johnston, a lawyer who helped draft Alabama's constitutional language on abortion in 2018, told the BBC: 'By and large the prolife community would say that fertilized eggs are in need of protection.' " (Alabama IVF Ruling: What Does It Mean For Fertility Patients? by Kayla Epstein). On August 2, 216 BC in the ancient village of Cannae in southeast Italy, the Carthaginians led by Hannibal surrounded and annihilated the Roman army commanded by Paulus and Varro. Pioneering the pincer movement, Hannibal accomplished the greatest feat in military history and inflicted on Rome its worst defeat. The defeat is depicted in American artist John Trumbull's 1773 masterpiece, The Death Of Paulus At The Battle Of Cannae. In the twenty first century, Trumbull's oil on canvas has been repainted with new characters. The Roman army is now America's constitutional government. Hannibal's pincer movement is now comprised of Marxists and Christians. The annihilation remains the same.

"The National Geographic Society has been organized to increase and defuse geographic knowledge, and the publication of a magazine has been determined upon as one means accomplishing these purposes." Noble words from Gardiner Hubbard, founder and first president of the National Geographic Society, written one hundred and thirty six years ago, in the first issue of the society's National Geographic Magazine. Knowledge, truth and enlightenment. For one hundred and thirty six years, these had been the watchwords of an American monthly magazine which had thrilled millions of people every month with its surveys of the natural world and studies of physical and human geography Knowledge, truth and enlightenment. For over one hundred and thirty six years, these had been the shibboleths of a magazine which educated millions of people every month in the lands, features, inhabitants and phenomena of the Earth. Circulated in dozens of languages throughout the world, winner of twenty five National Magazine Awards, and reaching through its Instagram page three hundred million followers, National Geographic had been a global institution of scientific understanding from its first issue published on September 22, 1888 up until the twenty first century. Then sickness struck, a sickness of the soul sweeping through the West, and laid low this iconic organ of popular science. We are here to invite you to come out in nature with us!' Now, what does being homosexual, or heterosexual for that matter, have to do with enjoying nature? I suppose the answer lies in how exactly one enjoys it. Wylie is, meanwhile, a doctrinaire leftist who sees his commitment to the outdoors as part of his efforts to advance the left's entire agenda." Look at *National Geographic* in the new millennium and see a portrait in print and digital editions of the treason of the West against its Age of Enlightenment.

Listen to the Magna Carta edition of 1354: "No man of what state or condition he be, shall be put out of his lands or tenements nor taken, nor disinherited, nor put to death, without he being brought to answer by due process of law." Listen to the renowned British jurist Edward Coke who wrote in 1608 in *Institutes* Of The Laws Of England: "No man shall be deprived [of his life, liberty or property] but by the law of the land, that is, by the common law, statute law, or custom of England, that is, to speak it once and for all, by the due course and process of law." One thousand years after the first enunciation of this fundamental principle of a free society, it has been rendered null and void in a land where it was proudly unfurled seven thousand kilometers away from its birthplace, unfurled in a New World land across the Atlantic Ocean, unfurled in a child land of Britain. One thousand years after the Magna Carta first set forth the principle that no person shall be deprived of his life, liberty or property without first having committed an act of force or fraud against another person, a judge in New York City has banged the gavel and dismissed the principle from the law books of the state. On February 16, 2024, one Arthur Engoron, a justice on the Supreme Court of the State of New York, issued a ruling in New York vs Trump which nullified the hallowed principle of due process of law. Founded on September 4, 1998 by Larry Page and Sergey Brin, two PhD students at Stanford University, Google was named after the number googol, a number with one followed by one hundred zeros, a number which stands for infinity. The number was chosen to signify the infinite capacity of the new search engine. In the twenty first century, this technological miracle house whose blessings to man in his quest to master space, time and the flow of information include such products as Search, Workspace, Android, Waze, Pixel and Nest, has given new meaning to its name. The meaning is now dark and sinister. In the twenty first century, the cancer on society which has proliferated uncontrolled under the name of Marxism and its race and gender offshoots has spread into Google. Gemini's bizarre results came after simple prompts, including one by *The Post* on Wednesday that asked the software to 'create an image of a pope.' Another Post query for representative images of 'the Founding Fathers in 1789' was also far from reality. Gemini responded with images of black and Native American individuals signing what appeared to be a version of the US Constitution—'featuring diverse individuals embodying the spirit' of the Founding Fathers. Another showed a black man appearing to represent George Washington, in a white wig and wearing an Army uniform. When asked why it had deviated from its original prompt, Gemini replied that it 'aimed to provide a more accurate and inclusive representation of the historical context' of the period. Generative AI tools like Gemini are designed to create content within certain parameters, leading many critics to slam Google for its progressive minded settings. Ian Miles Cheong, a right wing social media influencer who frequently interacts with Elon Musk, described Gemini as 'absurdly woke'. Social media users had a field day creating queries that provided confounding results. 'New game: Try to get Google Gemini to make an image of a Caucasian male. I have not been successful so far,' wrote X user Frank J. Fleming, a writer for the Babylon Bee, whose series of posts about Gemini on the social media platform quickly went viral. In another example, Gemini was asked to generate an image of a Viking—the seafaring Scandinavian marauders that once terrorized Europe. The chatbot's strange depictions of Vikings included one of a shirtless black man with rainbow feathers attached to his fur garb, a black warrior woman, and an Asian man standing in the middle of what appeared to be a desert. Famed pollster and FiveThirtyEight founder Nate Silver also joined the fray. Silver's request for Gemini to 'make four representative images of NHL hockey players' generated a picture with a female player, even though the league is all male. 'OK I assumed people were exaggerating with this stuff but here's the first image request I tried with Gemini, Silver wrote. [A] prompt to depict *The Girl With A Pearl Earring* led to altered versions of the famous 1665 oil painting by Johannes Vermeer featuring what Gemini described as 'diverse ethnicities and genders.' Google added the image generation feature when renamed experimental Bard chatbot Gemini and released an updated version of the product last week. The strange behavior could provide more fodder for AI detractors who fear chatbots will contribute to the spread of online misinformation." ('Absurdly Woke': Google's AI Chatbot Spits Out 'Diverse' Images Of Founding Fathers, Popes, Vikings by Thomas Barrabi). In response to the query what is Google?, more results appeared. Google operates an image generator which generates portraits stained with political correctness. These are portraits of gay couples, lesbian couples and interracial couples. These are images of black Founding Fathers and American Indians signing the Constitution. These are images of Marxist bias, machine misinformation and an attack on liberal values launched in the name of fairness, accuracy and political progressivism. Listen to them proclaim that cannibalism is legitimate and respectable because it was practiced by primitive cave dwellers to honor their dead. Listen to them proclaim that a progressive society promotes cannibalism in the name of achieving spiritual transcendence. Perhaps it is down to the fact that, in Western religious traditions, bodies are seen as the seat of the soul and have a whiff of the sacred. Or maybe it is culturally

ingrained, with roots in early modern colonialism, when racist stereotypes of the cannibal were concocted to justify subjugation. These came to represent the 'other' to Western societies-and revulsion towards cannibalism became a tenet of their moral conscience. A slew of recent archaeological discoveries is now further complicating how we think about human cannibalism. Researchers have unearthed evidence suggesting that our hominin ancestors ate each other surprisingly often. What's more, it seems that they weren't always doing so for the reasons you might expect—for sustenance or to compete against and intimidate rivals-but often as funerary rituals to honor their dead. Like it or not, then, cannibalism is an important part of our story. This isn't to say that we should change our attitudes towards it. But understanding its deep roots might shift our perspective on the few cultures that still practice cannibalism today, albeit only occasionally, such as the Aghori, a Hindu ascetic sect in India that does it in pursuit of transcendence. Above all, these discoveries invite us to reconsider our revulsion to cannibalism in the context of our evolutionary past." (Is It Time For A More Subtle View On The Ultimate Taboo: Cannibalism? New Scientist, February 14, 2024). Listen to today's Marxists proclaim that cannibalism is a natural, healthy, wholesome practice. Listen to them proclaim that cannibalism is moral and reasonable. Listen to them proclaim that cannibalism is a common practice throughout the animal kingdom is thus justified for people because people are not people but are nothing more than animals: "Since cannibalism is found throughout the animal kingdom and therefore is something natural, perhaps it is time for humans to rethink the 'ultimate taboo' against eating human flesh, Newsweek proposes in an article Wednesday. There is nothing necessarily unethical or unreasonable about eating human flesh, declare psychologists Jared Piazza and Neil McLatchie of Lancaster University, but careful reasoning over the merits of cannibalism is often 'overridden by our feelings of repulsion and disgust.' While not going so far as to recommend cannibalism, saying 'there is no need to overcome our repulsion for the foreseeable future,' the two authors suggest that humans could master their aversion for human flesh if they needed to. 'Many people develop disgust for all kinds of meat, while morticians and surgeons quickly adapt to the initially difficult experience of handling dead bodies,' they note. 'Our ongoing research with butchers in England suggests that they easily adapt to working with animal parts that the average consumer finds quite disgusting.' Moreover, the psychological revulsion experienced over the prospect of consuming human flesh is not the product of reason and may even contradict reason, they argue in Wednesday's article, which originally appeared last week in The Conversation. 'Survivors of the famous 1972 Andes plane crash waited until near starvation before *succumbing to reason* and eating those who had already died,' they propose. All sorts of animals eat members of their own species, from spadefoot tadpoles and Australian redback spiders to gulls and pelicans, they state. And cannibalism can even be found among mammals, they add, such as with many rodents as well as bears, lions, and chimpanzees." (Newsweek: Time to Rethink Taboo on Cannibalism? by Thomas Williams). As evaluated under the university's plagiarism policy, the paper contains at least three problematic patterns of usage and citation. First, Gay lifts an entire paragraph nearly verbatim from Lawrence Bobo and Franklin Gilliam's paper, Race, Sociopolitical Participation, and Black Empowerment, while passing it off as her own paraphrase and language. Second, Gay appears to lift material from scholar Carol Swain in at least two instances. In one passage, summarizing the distinction between 'descriptive representation' and 'substantive representation,' she copies the phrasing and language nearly verbatim from Swain's book Black Faces, Black Interests, without providing a citation of any kind. Third, Gay composes an entire appendix in the dissertation directly taken from Gary King's book, A Solution to

the Ecological Inference Problem. While she cites King's book—in fact, King was her dissertation advisor—Gay does not explicitly acknowledge that Appendix B is entirely grounded in King's concepts, instead passing it off as her own original work." (Is Claudine Gay a Plagiarist? by Christopher Rufo and Christopher Brunet). Claudine Gay, who still receives her presidential salary of \$900,000 per year. Claudine Gay, who proclaimed at a congressional hearing on December 5, 2023 that calls for the genocide of Jews is protected speech at Harvard, while calls for the genocide of blacks, women, capitalists, gays, lesbians and people who claim they are members of the opposite sex are not protected speech. Claudine Gay, who proclaimed at the congressional hearing that it is not absolutely wrong to call for the genocide of Jews but depends on the context, while it is absolutely wrong to call for the genocide of blacks, women, capitalists, gays, lesbians and people who claim they are members of the opposite sex. Sherri Ann Charleston, chief diversity officer at Harvard, whose 2009 doctoral dissertation for the University of Michigan was copied from a dozen scholars, including her dissertation advisor, Rebecca Scott. Sherri Ann Charleston, whose 2014 published paper was copied from a 2012 paper written by her husband, Lavar Charleston, and is described by Peter Wood, former provost at Boston University, as a counterfeit paper and "research fraud pure and simple." Shirley Greene, Title IX Resource Coordinator for Students at the Office for Gender Equity, who plagiarized her 2008 doctoral dissertation, entitled Converging Frameworks: Examining The Impact Of Diversity Related College Experiences On Racial/Ethnic Identity Development. The dissertation text was copied from a 2004 doctoral dissertation by Janelle Lee Woo entitled, Chinese American Female Identity, and from a paper entitled, Developing Leadership Skills for Diversity by Anthony Antonio. The table in the dissertation, entitled Racial/Ethnic Identity Development Models, was as well copied from Woo. Three black women, occupying Harvard's ruling circles, exalted as members of a new Aryan race and presiding over the final stages of civilization: "There was Claudine Gay, the one time Harvard President, who was a serial plagiarist, beginning with her dissertation and extending through seven of her eleven brief papers (she has no book), only one of which was peer reviewed, that make up her scandalously small list of publications. Her extensive plagiarism was the main reason she was forced to resign her position. For reasons that remain unknown, she continues to be paid her her former presidential salary of \$900,000; possibly those now in charge at Harvard wanted to keep her from accusing the university of racism, and letting her keep that preposterous salary was the best way to keep her quiet. There was Sherri Ann Charleston, the chief diversity officer at Harvard, who was discovered to have plagiarized extensively in her dissertation and handful of academic papers. So far she has managed to hold onto her job. I suspect Harvard administrators do not want to force the resignation of a second black woman found to be a serial plagiarist so soon after Gay's demotion. And now a third serial plagiarist in the Harvard administration has just been found. She is Shirley Greene, a Title IX coordinator affiliated with the Office for Gender Equity. According to the indefatigable Christopher Rufo, Greene claims to have worked to advance Diversity, Inclusion, and Belonging, without any evidence of how she has been doing this, and once led a panel on The Past, Present, and Future of Juneteenth with the DEI department. There doesn't seem to be much there there. She has just been found to have plagiarized at least forty passages in her dissertation. More on Shirley Greene, the latest—but almost certainly not the last—serial plagiarist to be uncovered at Harvard, can be found here: Harvard's Plagiarism Problem Multiplies, by Christopher F. Rufo, City Journal, February 22, 2024: 'Now allegations have emerged that another Harvard DEI [Diversity, Equity, Inclusion] administrator, Shirley Greene, of Harvard Extension School, plagiarized more than forty passages of her 2008 dissertation, Converging Frameworks: Examining The Impact Of Diversity Related College Experiences On Racial/Ethnic Identity Development. According to the Harvard directory, Greene is a Title IX coordinator affiliated with the Office for Gender Equity. She has worked to advance Diversity, Inclusion, and Belonging, and hosted a panel on The Past, Present, and Future of Juneteenth in

conjunction with the DEI department. (Harvard did not respond to an emailed request for comment). 'In the most serious instance, Greene lifts directly from Janelle Lee Woo's 2004 dissertation, Chinese American Female Identity. In two significant sections, Greene copied words, phrases, passages, and almost entire paragraphs verbatim, without proper attribution or quotation. She also copies most of an entire table on Racial/Ethnic Identity Development Models, a foundational concept in the paper, without acknowledging the source. We can examine one representative paragraph that illustrates the brazen nature of this adaptation. In her paper, Woo writes: 'Stage 2, White Identification (WI), is a direct consequence of the increase in significant contact between the individual and white society. This stage entails the sense of being different from other people and not belonging anywhere. The individual's self perception changes from neutral/positive to negative, and she begins to internalize the belief systems of white society. Consequently, the individual does not question what it means to be Asian American. Their self perception changes from neutral/positive to negative and they begin to internalize the belief systems of white society. In order to move to the next stage, the individual must acquire a political understanding of social status." (At Harvard, Another Case Of Plagiarism by Hugh FitzGerald). Convict number 440960. Soon afterward he joined the Marxist student group Students for a Democratic Society. In 1964, he joined the Extraparliamentary Opposition, a Marxist protest movement dedicated to "forcible resistance" and the forcible overthrow of the West German government. In 1970, he founded the Marxist terror group Red Army Faction, along with Andreas Baader, Ulrike Meinhof and Gudrun Ensslin. That year, he sprang Baader from prison, and the four committed a series of bank robberies, after which they fled to Jordan to receive training in guerrilla tactics with the Popular Front for the Liberation of Palestine. In 1998, he came full circle and returned to national socialism of his college days. Listen to national socialist Horst Mahler proclaim that race is the primary reality, individuals are mere shadow plays of the race, and Judaism is evil because it stands for reason, science, enlightenment, humanism and individual rights. Evidence of the shift taking place in Mahler's ideology came in 1977, in a commentary he wrote from prison in which he described 'that he was being internally freed from the dogmatic revolutionary theory of Marxism-Lenninism.' In spite of his changing world view, Mahler continued to receive support from young German leftists, including his attorney throughout this period, Gerhard Schroeder. Mahler was released on parole after ten years in prison. In 1988, his motion for reinstatement to the practice of law was rejected by the local authorities but that decision was reversed on appeal by the Bundesgerichtshof (Federal Court of Justice), which noted a sincere change in Mahler. It was not until late in the 1990s, however, that the extreme and improbable nature of Mahler's change began to earn him public attention. In an interview with the weekly newspaper *Die* Zeit, Mahler explained that the roots of his ideological shift lie in the disillusioning extremism of his experience in Jordan in 1970." (Federal Constitutional Court Issues Temporary Injunction In The NPD Party Ban Case, German Law Journal, Volume 2, Number 13, August 1, 2001). Horst Mahler. Paul Chesser, the director of the Corporate Integrity Project at the NPLC, told *The Daily Signal* that the NPLC has stock in Mondelez International, the parent company of Oreo. As the NPLC monitored the company's activities, Chesser noticed that Oreo's Twitter account was doing a lot of copromotional content with PFLAG. In many of these posts, Oreo praises PFLAG as a 'long time' partner, celebrates Pride Month, and promotes gender ideology. On closer examination, Chesser realized that Oreo was sponsoring the 2023 PFLAG National Convention. That convention's focus was 'Learning with Love, and its opening session was: Let Freedom Read! Read With Love To Support Inclusive Books And Education, pushing back on the banning of explicit books, according to NLPC. 'PFLAG and [the American Library Association] also cosponsored Banned Books Week earlier this month, which included Let Freedom Read Day to promote grassroots action with lawmakers and decision makers to allow adult themed materials into school libraries,' the NLPC said on its website. 'Among its events and materials for Banned Books Week, PFLAG made a list of the Top Thirteen Most Banned Books, which include the titles Gender Queer, All Boys Aren't Blue, Flamer, Lawn Boy and This Book is Gay. Multiple pages of these books contain explicit sexual content and gender ideology discussions. 'As watchdogs of corporate American, we believe that companies should not be engaged and involved in these divisive political issues, these social issues, they should be as neutral as possible,' Chesser explained. NLPC's campaign includes a website page dedicated to Oreo's partnership with PFLAG, where it reveals that it is sponsoring a shareholder proposal challenging Mondelez International's company executive and board of directors and asking the board to 'examine its associations with controversial external groups such as PFLAG to determine whether they present a significant risk to the health and profitability of the company.' 'Parents across the United States have become increasingly fed up with the political activism and gender ideology agenda-especially those targeting children-of militant LGBTQ pressure groups such as GLAAD, GLSEN, Human Rights Campaign, and The Trevor Project, among many others,' that landing page notes, critiquing activist groups for targeting children with *Drag Queen Story* Hour events and stirring up confusion about sex with terms like identity and fluidity. One element of the training described by a source was a slide test where users had to choose to move an image of a white person to a block that said 'bad' in order to complete the program: 'It had a word on the left, and it's a box, a word on the left, a word on the right, and an image. I needed to connect the image to one side, which determines your bias. Until you said that the white guy was bad it wouldn't let you move on. It said 'White Bad' on one side of 'Black Good' on the other and an image of a person came up and if you didn't drag it to the 'White Bad' category—the white man pops up in the middle—If you couldn't pass the test. They put an X in it and it won't let you move on.' Breitbart News also obtained a race training video that ranked the 'most racist judges,' as described by a source with knowledge of the training. The video, which played during the race training session, mentioned Florida, not Georgia, and used statistics not based on Fulton County data. It also spoke about judges being partisans, although judges in Georgia run unaffiliated. The audio of this clip has been muted to protect the identity of the source who provided it. 'You're set to appear before a judge, but you don't know who. Your best bet would be for the judge to be black and and male. Only 28 of the more than 450 judges who preside over serious criminal cases in Florida are black. So the judge would probably be white. If it's a white male, you can expect 20 percent more time in lockup than a white defendant. If it's a white female, you can expect ten percent more time. Politics also come into play. Republican judges sentence blacks 21 percent more time in lockup than whites. Democratic judges sentence blacks to 70 percent more time' multiple sources familiar with the Fulton County District Attorney's Office

But to the contrary, he said, '[the DOD's] denial of sharing facts has only empowered the gorilla in the room and gotten in the way of its mission.' Mr Spears and his family had planned for him to fulfill a thirty career, but in October, he chose to retire after two decades of service. 'In 2019, I began having doubts about the future of my career,' he said. 'There was a cultural fight in society that was becoming more and more evident in the Army itself.' According to him, the fight was between 'traditional, nonpartisan military culture' and 'another that was trending politically to the left.' aspects of the practice of advanced mathematicians in some periods—for example, the treatment of imaginary numbers for some time after Bombelli's introduction of them, and perhaps the attitude of some contemporary mathematicians towards the higher flights of set theory. Finally, it is often the position to which philosophically naive respondents will gesture towards, when pestered by questions as to the nature of mathematics." Thomae also remarks 'the formal standpoint rids us of all metaphysical difficulties'. One main motivation for formalists, then, is to block, avoid, or sidestep (in some way) any ontological commitment to a problematic realm of abstract objects. For standard mathematics entails a plethora of theorems affirming the existence of infinite realms of entities--numbers, functions, sets and so forth, entities which do not seem to be concrete. Formalists, in general, wish to divest themselves of any commitment to these domains which do, indeed, seem hard to fit into a thoroughly naturalistic conception of reality." (Formalism In The Philosophy Of Mathematics by Alan Weir). Look at the new class of witch doctors masquerading as mathematicians and see them proclaim that mathematical formulas are not true statements. See them proclaim that the mathematician is a mystical diviner, prognosticator, bead counter and crystal ball gazer whose revelations are independent of experience. See them proclaim that mathematics is a string of marks without meaning and computational aids computing nothing and established by a process of pure mental inspection. See them proclaim that mathematics is a system of pure syntax without semantics, content or intelligibility of any kind: "The gains which seem to have accrued to natural science from the use of mathematical formulas do not imply that these formulas are true statements. No one, not even the hardiest pragmatist, is likely to regard the beads of an abacus as true; and our position is that the formulas of Platonistic mathematics are, like the beads of an abacus, convenient computational aids which need involve no question of truth. The sentences of mathematics merely as strings of marks without meaning. Such intelligibility as mathematics possesses derives from the syntactical or metamathematical rules governing those marks." (Steps Towards A Constructive Nominalism by Nelson Goodman and W. V. Quine, Journal of Symbolic Logic 1947). Look at the new class of witch doctors masquerading as mathematicians and see them proclaim that numbers are fictions which number nothing. See them proclaim that numbers are negative, irrational, complex and contradictory, and are

everything and anything except real. See them proclaim that the operations of addition, multiplication, subtraction and division are operations performed on nothing. See them proclaim that the laws of commutativity and associativity governing addition and multiplication are laws governing no objects. See them proclaim that the process of exponentiation is the exponentiation of nothing. See them proclaim that mathematics, far from being an empirical science, is a morbid, unnatural exercise in mental navel gazing: "In the latter part of the nineteenth century several notable German mathematicians professed a formalist attitude to certain parts of mathematics. In conformity with Kronecker's famous 1886 declaration Die ganzen Zahlen hat der liebe Gott gemacht, alles andere ist Menschenwerk, [The whole numbers were made by God, everything else is the work of man]. Heinrich Eduard Heine (1821-1881), Hermann Hankel (1839-1873), and Carl Johannes Thomae (1840-1921) all understood theories of negative, rational, irrational and complex numbers not as dealing with independently existing entities designated by number terms, but as involving the useful extension of the algebraic operations of addition, multiplication, exponentiation and their inverses so as to enable equations without solution among the natural (positive whole) numbers to have solutions. In this way whereas an expression like 2+5 unproblematically stands for the number 7, an expression like 2-5 has sense not by denoting a number -3 but as part of the whole collection of operations regulated by their characteristic laws such as associativity, commutativity, and so on." (Formalism by Peter Simons). For centuries skyscrapers towered above the West and loomed over the lives of its citizens. These skyscrapers were marked reason, science and sanity. In the twentieth century an earthquake struck. Amidst the thunderous roar of civilizational collapse, witch doctors, arrived from distant, alien, savage shores, donned the garb of mathematicians. They proclaimed that mathematics is a meaningless game played in accordance with arbitrary rules and containing nonsense elements. They proclaimed that mathematical systems which are complete contain contradictions and in such antisystems and nonsystems nothing can be known or proved. Proclaiming that mathematics is an exercise in formalism, inconsistency, undecidability and unintelligibility, wearing illustrious professors' robes marked with such names as David Hilbert and Kurt Godel, they helped to bury the West.

THE MARRAKESH EXPRESS

The Divine Comedy is fourteenth century narrative poem by Dante Alighieri. The preeminent work of Italian literature, and among the preeminent literary works in the West, the poem is a portrait of the afterlife imagined by the Christian church. The first part of the poem, called *Inferno*, describes a journey into hell. This realm is described as nine concentric circles of torment located below the surface of the Earth. It is the realm of those who have rejected morality and pursued animal appetites, animal vices, animal violence, and deployed the intellect to commit acts of fraud, force and malice. See people forever frozen, forever ancient and forever incapable of flourishing in the manner of human beings. See people whose life and spirit were hermetically sealed up against reason and enlightenment. See people who lived their lives in dull, stuporous, unconscious inactivity. See people whose existence defined the words stagnation and vegetation. See people who lived in perpetual outer darkness and dilapidation, without light, wholesomeness or health, far removed from the ever fresh and ever growing radiance of Europe, located a short fourteen kilometers away. See people sick in the soul and in perpetual servitude to Islam, fierce in their religious fanaticism and fierce in nothing else, obstinate in their religious fanaticism and obstinate in nothing else, entrenched in their religious fanaticism and entrenched in nothing else, walled up behind dungeons of ignorance and superstition, weary and miserable whenever they could not bow down in blind submission to Allah, mindless puppets dangling from wires of fear and control, forever directed and racing backward in time, into the rubble and wreckage of history and humanity: "In Morocco, nature-which is often described as immutable-seems to have changed much more, undergone more modifications, through the centuries, than man-this unstable and mobile being-than the customs of the country [Morocco], than the psychology of its inhabitants, whose way of being seems to have been crystallized for several centuries. If we look closely at the Moroccans of today, we can read with an open book the obscure past of this weightless people, so little impressed by the influence of the ages that have passed on them almost without modifying it, without affecting its antiquated soul, without disturbing it in its refractory archaism. The phenomena, external to man, which surround him and which do not live, have varied, the scenery has been transformed—[Moroccan] man has remained frozen. Thus it appears, if we refer to the accounts of ancient travelers, that the soil, the climate, the atmosphere have changed with time, no longer permitting, for example, the cultivation of cotton and sugar cane, which once flourished on the land of the Maghreb. Now, while this slow evolution has been accomplished in the environment which has patiently adapted itself to new climatic requirements, the Moroccan has not evolved in parallel with the progress of other peoples, has not adapted himself to the new social conditions which have so profoundly modified the life of nations and the minds of individuals. Nothing has been able to penetrate his closed soul, entrenched behind the antiquated ramparts of his beliefs. All this [Morroccan] world exists and vegetates apart from time, without civilization, which nevertheless clashes with the old walls fierce and jealous of keeping their dilapidation, bringing it anything other than its rumor. This closed world, which lives on the margins of radiant Europe, this hermetic people nevertheless suffers from its weariness and misery, but refuses the help of its Western neighbors. The stubbornness of prisoners who are obstinate in their dungeons and who reject freedom, health, light and ease. A reverie that has gone back several centuries, the obstinacy of fanatics, the bias of a obsolete and disjointed puppet who refuses to make reparation to the worker. Moroccans vegetate, superfluous and obsolete, in a retrograde atmosphere, the wreck of finite ages and superstitious beliefs." (Witchcraft In Morocco by Emile Mauchamp). Now look at postcolonial Morocco and see a tragic repetition of history and a land travel full circle back into its ignominious past. See a land without human health or hygiene. See a land carpeted from border to border in animals dead and alive. See a land swimming in trash and filth. See a land whose cities, countryside, mountains and waterfalls lie buried in garbage. See a land poor in life, soul, work and economy. See a moral desert and vacuum bleed society white. See a landfill masquerade as a society and send foul emanations racing up to the heavens. See animal people unconcerned about the environment and unable to manage tourism. See a land unable to sort trash, dispose of trash or recycle trash but able only to produce trash and consume trash. See miasmic dung heaps and black clouds of flies masquerade as a culture. See trash bins and trash heaps masquerade as neighborhoods

and cities. See overflowing communal dumpsters masquerade as apartment complexes. See residential doors conceal reeking filth inside. See a land offensive to the senses, repulsive to look at, locked in primitive prehistory and, except for a brief interlude under French rule, dead for five thousand years: "I won't sugarcoat it: There's trash everywhere. This presents a constant burden to locals, and it's also unsurprisingly one of the first things Western tourists notice upon arriving in the country. Travel blogger Allane Milliane pulls no punches when describing Morocco: 'It's dirty and lacks hygiene,' she says. 'Papers, plastic, dead rats and pieces of dead animals such as chicken heads, flies everywhere, feces (both human and animal), and trash, lots of trash, I mean plastic bags filled with trash just sitting in the middle of the streets,' she writes of the sights to behold in Marrakech and Chefchaouen. 'On the road you will see trash everywhere, even in the desert and near beautiful waterfalls, to my disappointment,' she says of the Moroccan countryside. 'Can you blame it on the lack of education of the locals because Morocco is a poor country? Probably yes, but it's hard to understand that the same locals that rely on tourism so much, are so careless with the environment. It's simply sad.' Picture a typical suburban American neighborhood. It's trash night, and each household has put their two 96gallon bins---one for recycling, one for the landfill---at the curb. By 9 am the following morning, the bins will be empty, their contents whisked away to the proper sorting and disposal facilities; or, more likely, shipped off to the developing world to become someone else's problem. Out of sight, out of mind. Single household recycling and garbage bins in the US state of Pennsylvania. These are emptied once a week by a private waste disposal company. Now imagine an old Moroccan medina. Have you ever seen two ninety six gallon garbage bins perched beside any of those gorgeous residential doors, waiting to be emptied to make room for next week's waste? No, you haven't. What about outside the medinas, in the newer neighborhoods composed primarily of apartment buildings? Does each household have those ninety six gallon garbage bins? Well, of course not! They live in apartments! Surely each complex has a communal dumpster! Wrong again. Apartment complexes do not have their own dumpsters, but most neighborhoods do. However, these dumpsters are pitiful, to say the least. They're small, constantly overflowing, foul smelling, and horrible to look at. The worst thing about these dumpsters is that they are often inaccessible to most residents of any given neighborhood, especially in lower income areas. Usually you can only find them every few blocks, and sometimes not at all." (In Defense Of Morocco's Everyday Sustainability by Morgan Hekking). The story of Morocco is a story as old as time. It is the story of animal people roaming distant lands for thousands of years, then taken into captivity by the forces of civilization, then set free by these self same forces beneath a surrender flag marked decolonization, and then reverting back to their primitive state. It is the story of savagery thundering for thousands of years in freedom and license, then pacified and chained up, and then unleashed with a gate key stamped the suicide of the West.
