

Mzia Amaghlobeli Remanded in Custody Amid **Controversial Allegations**

n March 4, Batumi City Court remanded journalist Mzia Amaghlobeli, founder of Batumelebi and Netgazeti, in custody. The decision was met with tension in the courtroom, where Amaghlobeli held up a piece of paper reading "Unjust Court."

Amaghlobeli had been on a hunger strike for 38 days, which she ended on February 18. Despite her health condition, she was present at today's hearing. The prosecution introduced new claims, alleging that Amaghlobeli had communicated with others in advance to plan an "attack on the police." They cited a detective's report dated February 15, which claimed that Amaghlobeli had been in contact with unidentified individuals regarding the attack. Based on this. the prosecutor requested access to her phone to extract data. However, Amaghlobeli's defense team opposed the request, arguing that it was an attempt to gain access to personal information without adequate evidence.

The prosecution also argued that Amaghlobeli posed a risk of absconding and destroying evidence, justifying her continued detention. The defense strongly contested this, asserting that




there was no legal basis for her imprisonment and that the remand was excessive. "A slap with the left hand is not an assault on a police officer," the defense argued.

At the hearing, Amaghlobeli declared, "I don't think I'm guilty, I see myself as illegally imprisoned," expressing confidence that she and other prisoners of conscience would eventually prove their innocence.

Amaghlobeli's case has drawn significant attention, with supporters, including journalists, human rights defenders, politicians, and diplomats, gathering outside the courthouse. Among those present were French Ambassador to Georgia, Shéraz Gasri, Deputy Head of Mission at the German Embassy in Georgia, Esther Wagner, and Head of Political Affairs at the Swedish Embassy, Erik Malmberg.

Ahead of the hearing, the German Foreign Ministry had called for Amaghlobeli's immediate release, adding to the growing international pressure surrounding the case.

Europe Press Freedom: Georgia Faces Sharp Decline in Press Freedom

rapid deterioration of media freedoms in Georgia, marking the country as having the highest increase in press freedom alerts among all Council of Europe member states. This decline has further distanced Georgia from democratic principles and hindered its European Union integration. A fact-finding mission conducted for the report in October 2024 found that press freedom in Georgia is under severe strain. The mission documented increasing efforts to discredit and suppress independent journalism, particularly targeting critical media outlets. The report notes that the 26 October 2024 parliamentary elections took place amid a

> At least 70 journalists were subjected to verbal and physical attacks, intimidation, and obstruction on election day.

> Several pro-opposition TV channels, including Mtavari TV, were fined by the Communications Commission for refusing to air political advertisements.

> Following the elections, Prime Minister Irakli Kobakhidze announced the suspension of Georgia's EU accession process until 2028, trigger-

Tbilisi City Court Judge Remands 11 Protesters on Charges of Group Violence

The defense team for the accused contested the remand, arguing that the prosecution's claims were unfounded and lacked substantial evidence. They characterized the prosecution's arguments as generic and unsupported by the facts of



Tbilisi City Court Judge Irakli Shvangiradze has remanded 11 individuals arrested in connection with organizing and participating in group violence during recent protests. The defendants include Andro Chichinadze, Onise Tskhadadze, Guram Mirtskhulava, Jano Archaia, Luka Jabua, Ruslan Sivakov, Revaz Kiknadze, Giorgi Terashvili, Valeri Tetrashvili, Sergey Kukharchuk, and Irakli Kerashvili.

The prosecutor's office sought their remand, citing concerns about potential flight risks, the possibility of further criminal activity, and the destruction of evidence.

Giorgi Bachiashvili Secretly **Crosses Border into Armenia**, **Faces Legal Charges**

The Ministry of Internal Affairs has confirmed that Giorgi Bachiashvili, the former head of co-Investment Fund, illegally crossed the border into Armenia on March 2. According to the Ministry, Bachiashvili bypassed the border checkpoint, using a concealed hiding place in a car to evade detection.

The Ministry stated that the investigation is ongoing under Part 1 of Article
