# Georgian Dream Rejects EU's Kaja Kallas' Concerns Over Arrests and Protests

The High Representative of the European Union for Foreign Affairs and Security Policy, Kaja Kallas, has expressed concern over the arrests of individuals in Georgia, stating that pressure is being put on those who are using violence against peaceful protesters.

"We have been putting pressure on those who are actually conducting violence against peaceful protesters," Kallas noted.

In response to Kallas' statement, Georgian officials dismissed her remarks as unfounded. Kakha Kaladze, the Secretary General of the Georgian Dream party and Tbilisi Mayor, labeled the EU High Representative's statements as based on "lies," asserting that they "have no value."

Kaladze added, "We hear such unfair statements very often. This is not new to us. Basically, the statements made by them are based on lies, falsehoods, and have no value."

Kaladze also addressed media reports suggesting that 15 countries are calling for new elections in Georgia, describing it as "ordinary nonsense" and urging foreign officials to focus on their own countries instead of inter-



fering in Georgia's domestic affairs.

"This is ordinary nonsense. It is better for them to take care of their own countries and stop interfering in the internal political affairs of other countries," Kaladze stated.

Levan Makhashvili, the chairman of the parliamentary

committee on European integration, also criticized Kallas' remarks, calling them "not serious." He suggested that there is a specific interest in the issue of Georgia from certain individuals who are trying to create an "alternative agenda" and assist the opposition in radicalizing its actions.

"At least it is not serious. In general, where this statement was made - at the Foreign Relations Council, for the first time in recent years, the agenda is what actually the problem of the European Union is. These are all the crises, wars, and political tensions that exist both inside and outside the European Union. Georgia is not logically on this agenda, because Georgia has not been and will not be the main problem that the European Union will focus on – Georgia was, is, and will generally be a reliable partner of the West in this region," Makhashvili said.

He further claimed that the focus on Georgia by certain EU officials is motivated by personal interests and attempts to fuel "radical opposition" actions.

"What is evident is the personal interest of specific individuals in the issue of Georgia and their interest in creating an alternative agenda and helping the radical opposition in further radicalizing their steps. We are only observing this. Nothing else interesting is coming from her or her colleagues," Makhashvili added.

# Prosecutor's Office Accuses Several Foundations of Funding Violent Protests, Seizes Bank Accounts

The Prosecutor's Office of Georgia has announced the seizure of bank accounts belonging to several organizations, accusing them of financing individuals involved in violent protests and criminal activities. Based on a court ruling, the accounts of the "Nanuka Foundation," "Prosperity," "Fund for Each Other 24/7," "Shame," and "Tbilisi Human Rights House" have been frozen in all banking institutions across Georgia.

According to the Prosecutor's Office, these organizations directed financial resources toward activities that allegedly incited and facilitated unlawful actions. Officials claim that the funds were used to support individuals involved in protests, purchase equipment, and provide financial aid to those accused of organizing group violence. Some transactions reportedly included descriptions such as "necessary equipment for protests," "what is needed for the fight," and "purchase of pyrotechnics."

The investigation, covering the period from November 28, 2024, to the present, suggests that some protests held in front of the Parliament and other locations escalated into violence. The Prosecutor's Office alleges that demonstrators damaged government buildings, private property, and police vehicles while using incendiary substances, Molotov cocktails, and other dangerous items against law enforcement officers. Officials report that at least 55 individuals were injured, most of whom were police officers.

Authorities also claim that organized groups within the protests were systematically supplied with respirators, gas masks, helmets, and other protective gear, allegedly to enhance their ability to confront law enforcement. They argue that financial transactions linked to the accused organizations indicate a pattern of deliberate funding for such activities.

In addition to funding individuals allegedly engaged in violent acts, the Prosecutor's Office states that the seized funds were also used to assist the families of arrested individuals, pay legal fines, and cover other expenses. Officials contend that this financial support not only facilitated unlawful actions but may have encouraged further participation in criminal activities

The Tbilisi City Court has found Mikheil Saakashvili, the third president of Georgia, guilty of illegally crossing the state border, sentencing him to 4 years and 6 months in prison. Additionally, he was sentenced to 8 years for embezzling state funds, bringing the total sentence to 12 years and 6 months.

In response to the court's decision, Saakashvili condemned what he called a series of illegal and "shameful" actions by the government, which he accused of using the judicial system to destroy him physically while behind bars. He referred to the court ruling as an act of "destrucVolodymyr Zelensky. "They are telling him that the same fate awaits him if he does not surrender Ukraine," Saakashvili

# Canada more than triples its contribution to **EU-managed Energy Support Fund for Ukraine**

The Canadian government L has significantly increased its contribution to the Ukraine Energy Support Fund, raising it from CAD 20 million (Euro12.8 million) to CAD 70 million (Euro44.8 million).

The increased contribution will enable the Energy Community Secretariat, co-chaired by the European Commission, in collaboration with the Ministry of Energy of Ukraine, to address the most pressing needs of Ukraine's energy sector.

The latest Rapid Damage and Needs Assessment (RDNA4) estimates that damage to Ukraine's energy sector has reached US\$20.51 billion as of 31 December 2024 — more than double the damage recorded in the previous assessment.

Since its launch in April 2022, the Ukraine Energy Support Fund has mobilised over Euro 1 billion from more than 30 donors, enabling the repair of power generation, transmission, and distribution infrastructure, and the supply of vital equipment to over 56 energy companies across 21 regions of Ukraine.

On 27 February, the Energy Community Secretariat received a formal notification from USAID regarding the termination of its Grant Agreement with the Ukraine Energy Support Fund, valued at US\$ 75 million.
