Georgia, U.S. Discuss Economic Cooperation and Innovation Partnerships

According to the Ministry of Economy and Sustainable Development, Georgia's First Vice Prime Minister and Minister of Economy, Levan Davitashvili, met with U.S. Ambassador Robin Dunnigan to discuss strengthening economic ties and exploring new opportunities under the new U.S. administration.

The meeting, held at the Ministry of Economy, was attended by Deputy Minister Genadi Arveladze and Deputy Head of the Economic Section at the U.S. Embassy, Diana Costa.

According to the ministry, discussions focused on Georgia's economic priorities and potential areas of cooperation with the United States, including innovation, technology, trade, transport and logistics, the Middle Corridor, and investment in the energy sector.

The statement noted that Georgia's first international technology hub is planned to be established this year in San Francisco. The project aims to support the internationalization of Georgian startups, provide them with access to global markets, and attract interest from global technology companies, venture capital funds, and angel investor networks. The ministry highlighted that the initiative will be implemented by



Georgia's Ministry of Foreign Affairs and the Innovation and Technology Agency, with active support from the U.S. Embassy. The statement also mentioned

the facilitation of trade missions between the two countries, with Georgian businesses traveling to the U.S. Embassy. talso mentioned the facilitation of trade missions between the two countries, with Georgian businesses traveling to the U.S. and American companies visiting Georgia in the com-

ing months. The Ministry of Economy and the U.S. Embassy will actively support these efforts.

According to the ministry,

both sides emphasized the importance of deepening economic cooperation and enhancing bilateral trade and investment relations.

Zourabichvili: Russian Propaganda Has Gained Influence in Georgia

Georgia's fifth president, Salome Zourabichvili, stated during a hearing at the UK Parliament's Foreign Affairs Committee that Russian propaganda has gained significant influence in Georgia, with the Kremlin regularly praising the country's leadership in recent years.

When asked how the ruling Georgian Dream party has changed over the past 13 years, Zourabichvili noted that its stance was initially pro-European but began to shift around 2021.

"In 2012, when they came to power, they followed their program, which was to continue Georgia's Euro-Atlantic course. In 2018, they even adopted an article requiring all institutions in Georgia to support European integration. This was the article I referenced during my impeachment process," she said.

However, she argued that over time, the party started consolidating power and restricting the media and judiciary. According to Zourabichvili, the shift intensified with the war in Ukraine, as the government's rhetoric turned anti-European and anti-Western.

"Around 2021, changes became more apparent. The government began concentrating power, restricting the media, and interfering with the judiciary. This process accelerated after Russia's invasion of Ukraine, with statements that Georgia would not join sanctions and claims that Western partners were trying to open a 'second front' in the country," she said.

When asked why this shift happened, Zourabichvili suggested that Georgian Dream's pro-European stance may not have been genuine.

"Perhaps their commitment to European integration was only superficial, easy to maintain when no major challenges existed. But when pressure mounted, Russia likely exerted influence over individuals it has leverage on—and Bidzina Ivanishvili is one of them," she stated.

Zourabichvili concluded that Russian propaganda has played a growing role in shaping Georgia's policies, both domestically and internationally.

Mamuka Khazaradze Charged for Failing to Comply with Parliamentary Commission's Request

The statement from the Prosecutor's Office outlines that Khazaradze was summoned to appear before the Temporary Investigative Commission on March 25. The commission was set up to examine the activities of Georgia's previous government from 2003 to 2012. He was officially notified of this obligation on March 22, with a document signed by the commission's chairman. Despite being informed of the legal consequences of noncompliance, Khazaradze did not attend the session without providing a valid rea-

He criticized the process, noting that the initial letter from the Prosecutor's Office did not specify which case he was being summoned for, and this information was only clarified after his lawyer made an inquiry.



The Prosecutor's Office of Georgia has charged Mamuka Khazaradze, leader of Strong Georgia, for failing to comply with the lawful request of the Temporary Investigative Commission of Parliament. According to the Prosecutor's Office, a preventive measure will be requested from the court within the legally established timeframe.

As a result, he has been charged under Article 349 of the Criminal Code of Georgia, which pertains to the failure to comply with a Temporary Investigative Commission's request. The charge carries penalties including a fine or imprisonment for up to one year, as well as the possibility of being barred from holding office or engaging in certain activities for up to three years.
